After the business meeting and dinner, the Camp was treated to an excellent presentation by two distinguished

guests: Colonel Donald W. Outler and Colonel Van Skiles of the Commemorative Air Force - Gulf Coast Wing.



The Colonels presented information about their organization which consisted of 2 parts; the 1st part about the Commemorative Air force; and the 2nd part about the Gulf Coast Wing located here in Houston. We are familiar with the Commemorative Air Force mostly for the annual Wings Over Houston Air Show - the next being scheduled for this October 31st and November 1st. The organization was formerly known as the Confederate Air Force, but they changed their name to Commemorative Air Force in 2002. They are the world's 8th largest Air Force. We note that they maintain their aircraft in *flying* condition. There is a significant difference between an aircraft that is a static display and one where you can see and hear it fly.

The presentation began with a video clip of some of the Commemorative Air Force (CAF) aircraft taking off. There was a short scene demonstrating how difficult and quick air-to-air combat was and highlighted two of their most popular aircraft: the *CAF's* first airplane "Red Nose" (a *P-51 Mustang*), and their WWII B-29. The *CAF* has over 8,000 members in 28 states and 4 foreign countries. The *Gulf Coast Wing* here in Houston has 167 members. The CAF owns 172 aircraft in over 60 types, so there is very little duplication. Here in Houston, the Gulf Coast Wing (GCW) is responsible for the "Texas Raiders", a B-17G, and 11 reproductions of Japanese fighter aircraft.

The *CAF* has the only flying B-29 Super Fortress left in the world! Her name is *FIFI*. They also maintain other rare aircraft which are either one or two copies left in flying condition. Several video clips of *CAF* aircraft in flight were shown during the presentation. The *CAF* has U.S. manufactured military aircraft and also maintains aircraft manufactured by foreign countries during WWII. The WWII German Tri-Motor, for example, is one of their exotic aircraft.

Colonel Outler took a moment to call members of the *Camp* who are military service veterans to stand and be recognized for their service to their country.

A video clip showing the acquisition and restoration process of their B-29 was very interesting. There were also video clips of their *Tora, Tora, Tora* flight routine utilizing their Japanese fighter aircraft reproductions portraying the December 7, 1941 attack on Pearl Harbor. A video clip showing their fighter and bomber aircraft moving in review at the annual Midland, Texas air show was also presented.

The *CAF* is a 501c3 organization, and by act of the *Legislature of the State of Texas* is the "Official" Air Force of the State of Texas. The emphasis of the *Commemorative Air Force* is to honor the men and women who built, serviced, and flew those historic aircraft in order to preserve our freedoms. Their primary objective is education about the sacrifices made for our freedoms, and the contributions made by their aircraft.

The presentation then moved into information about the WWII B-17G "Texas Raiders", an aircraft currently undergoing a 3rd restoration process at *Hobby Airport* in Houston. Texas Raiders was built in 1945. It was grounded in 2001 by a FAA Airworthiness Directive (along with all other B-17's in the U.S.) for cracks and corrosion in the wing spars and the wing roots that connect the wings to the fuselage. The CAF determined that they would do a complete and deep restoration so when Texas Raiders is returned to flight, she would be able to continue to fly for several years without additional extensive maintenance. There was a short discussion about the aircraft being all electric, with the only hydraulic components being the brakes and cowl flaps.

An amazing video clip was presented which showed Colonel Van Skiles flying *Texas Raiders* down the runway with only one wheel down and trailing smoke during an air show. It was a spectacular example of flying skill! This particular air routine is no longer flown due to being simply too dangerous for the spectators, air crew and airplane.

Colonel Skiles spent some time discussing his experiences as a *CAF* pilot. He learned to fly in his family flying business and went on to serve as a pilot in the *Army Air Corps* during WWII. He has flown over 19 different types of aircraft, including balloons and gliders. He has flown over 30,000 hours as a pilot which, in the aviation world, is a high time and experience level very few pilots achieve. He discussed his career as an airline captain, and his exploits in flying *Texas Raiders* over the Pentagon and up the Potomac in Washington D.C. Since that particular exhibition was so unusual, the *Dulles Air Traffic Control* parked all the incoming aircraft in a holding pattern – including the commercial flights - so the staff in the tower could go outside and watch the flying. Also, the Colonel's flying was so unusual that at the big annual Fly-In in Oshkosh, they shut down all of the flying just to let him show how to fly a B-17. His fellow pilots gave him the honor.

Many photos of *Texas Raiders* was shown as she was about a year ago, and a photograph as she appears today. The *Gulf Coast Wing* is on schedule to have *Texas Raiders* back in the air in September 2009. The final video clips were views of the B-17G cockpit in flight showing pilot and co-pilot coordination, and a takeoff and landing through the clear nose bubble - which is the most spectacular seat in the airplane!



The July 2009 Camp meeting was called to order at 7:00 p.m. at the Spaghetti Warehouse restaurant in Houston

In addition to Brothers Hackett, Leach, and Burdette, SVC David LaBrot, JVC Sam Hampton, Secretary/Treasurer Gary White, Steve Holmes, Tom Eishen, Michael Lance, and William Boyd were in attendance. Guests on hand included Joel Reed and Lee Edwards. The meeting was further enhanced by the presence of Betty Hampton, representing the *Sarah Emma Seelye SUVCW Auxiliary*, and Martha Class, representing the *Sarah Emma Edmonds Detached Tent #4 DUVCW*.

SVC LaBrot, representing the *Recruiting Committee*, reported that a new period-correct recruiting tent will be purchased this month. The new tent will be a wall tent with 7 foot high walls.

Cmdr. Hackett, representing the *Speaker's Committee*, reported that he will make the featured speaking presentation in September and Brother Burdette will be the featured speaker in October. Both men are accomplished presenters and their talks are always interesting.



Brother Holmes expressed his regrets for being unable to attend the upcoming memorial service for his Civil War ancestor due to a scheduling conflict. He also updated the *Camp* on his efforts with selling personalized paving bricks designed to raise the needed \$4 million for the *Buffalo Soldiers National Museum* in Houston. He thanked the *Camp* for their support for the project. A motion to purchase a \$100 brick in the name of the *Camp* was raised and passed.

Brother Steve Holmes

The Edward Lea Camp was recently invited by the Dick Dowling Camp 1295, SCVCW of Beaumont, Texas, to participate in the re-enactment and dedication ceremonies planned for the September 11-13 reopening of Sabine Pass Battleground Park at Sabine Pass. Interest for attending the event was high.

Our presence was deemed extremely important since the

monument honoring the Union casualties is one of the few memorials still standing in the park following the destruction caused by hurricanes *Rita* and *Ike*. Our Camp had originally dedicated the 6-foot tall granite monument on September 8, 2007 (see 'Sabine Pass Monument Dedication', Vol. 14, No. 4, pg. 5, Winter 2007, Harriet Lane newsletter).

SVC LaBrot announced the creation of a new *Department of Texas* newsletter. The newsletter will be edited by Dept. JVC Brian Glass. Among other *Department* news, it was mentioned that each *Camp* is required to provide a volunteer to act as a *Department Consultant*. PCC Stephen Schulze volunteered to serve in that capacity.

Brother Eishen, who recently volunteered to act as webmaster, reported that our current website has inadequate space to handle our needs properly. Our current website is free – but limited. After outlining his ideas to improve the look of our website and the additional features necessary to meet our needs, Brother Eishen recommended upgrading to a 'paid' site. He volunteered to search for a suitable site and then manage the upgrade. A motion to approve Brother Eishen's recommendations was offered and approved. An enhanced on-line presence for the *Camp* will most likely be the result.

Following a moment of silence for the recovery of Thomas Shuster, son of Brother Scott Shuster, an invocation was offered by Brother Leach. The meeting was then adjourned by Cmdr. Hackett at 7:45. After a short intermission, the *Camp* reassembled for a presentation by guest speaker, Brother Tom Eishen (*recap on pg 7*).

Changes at Gettysburg Battlefield

At 8:03 p.m. on July 14, 2009, Brother Tom Eishen assumed the role of guest speaker. As usual, he gave an interesting presentation. His focus was on the changes at *Gettysburg National Military Park*. He has conducted extensive study and research of the battleground area, including several personal visits. Brother Eishen described the ongoing 20-year plan to restore the battlefield grounds to as it once was. He showed slides depicting numerous well-known landmarks, including: *Little Round Top, Devil's Den, Pitzer's Woods, Cemetery Ridge, Warfield Ridge*, the *Rose Farm*, the *Triangle Field*, the *Slyder Farm*, the *Peach Orchard*, the *Wheat Field*, the *Trostle Farm, Power's Hill*, and several statues and regimental monuments.

Of special interest was a sequence of slides showing before and after views of the removal of trees and brush to clear some fields – while in other areas, planting native species. The tearing down of the old visitor's center, the replanting of the *Peach Orchard*, the clearing of the fields, and strategic replanting efforts, have all helped to return the area to more closely resemble how it looked in the 1860's.

Brother Eishen then reviewed the placement and movement of the various units during the historic battle. He displayed slides showing the view from both the Union and Confederate lines. He also related the story about Stephen Brown and: his arrest for getting his men water; his going into battle with a hatchet; his capture of a sword from a Confederate officer to replace the hatchet; and his monument showing him holding the sword with the hatchet at his feet.

Brother Eishen used a computer and projection screen to describe and show the battlefield as it looks today and how it looked several years ago. He used several of his own panoramic photos which he seamlessly joined together by computer to be able to pan back and forth across nearly the entire battlefield – from different angles and distances. An interesting and valuable learning use of technology, for sure! Thank you Brother Eishen, for an impressive and informative presentation!

Camp Acquires New Recruitment Tent

After much discussion and research by the Committee, a 12' x 14" sized tent with 7' walls was chosen. The tent comes complete with poles and storm ropes with 18" stakes. The storm ropes option was chosen in order to keep the new tent stable in the event of inclement weather. Purchasing a stronger and larger tent having heavy-duty tie down gear was a priority this time since rain and/or gusty winds destroyed our two previous lighter-weight recruiting tents. The new tent will be shipped to us October 15th. It should arrive in Houston the following week. The *Camp* should have plenty of time to practice setting it up before our major recruiting effort takes place during the *Civil War Weekend* event at Liendo Plantation in November.

Civil War Soldiers Finally Rest in Peace

Thursday, May 28, 2009

Discovered two years ago in graves unearthed at a construction site, the remains of 61 Civil War-era veterans and three civilians were reinterred at *Southern Arizona Veterans Memorial Cemetery* in Sierra Vista, Ariz., May 16. The caskets were escorted along their route by *American Legion Riders*, the *Arizona Highway Patrol*, *U.S. Border Patrol* and other patriotic groups.

A memorial ceremony honored 22 California Volunteers who fought during the Civil War, and 39 regular Army troops who served at various times between 1866 and 1881. The remains included those of three Army Indian scouts and one unknown Civil War veteran from the *U.S. Colored Troops*.

Soldiers from nearby Fort Huachuca helped to carry the troops' remains – in small, U.S. flag-draped coffins – to a ceremonial staging area. Arizona's official balladeer, Dolan Ellis, sang "Amazing Grace," and Joe Joaquin said a prayer in his native Indian language. The 4th Cavalry Regimental Band provided music for the memorial ceremony, which was hosted by the Sons of Union Veterans of the Civil War.

Letter Sent Home From Behind the Front

This is the 2nd letter submitted by Auxiliary President Vali Reyes which was originally penned by Civil War soldier John Davis. It is one of several messages sent home from the front by Private Davis to his family. We are fortunate that Sister Reyes has offered to transcribe some of his letters for us for review in this and future issues of the Harriet Lane.

Private Davis was a brother of Julianna Davis Leonard, Vali's 2^{nd} gr-grandmother. He was born about 1835 in Berkeley Springs, Bath County, Virginia (now WV). Pvt. Davis enlisted July 26, 1861 at Cumberland, Maryland. He served with the 5^{th} PA Reserve Corps, Co. $G-34^{th}$ Vols. and saw battle at Antietam, Fredericksburg and Gettysburg. He was wounded in his upper thigh at Fredericksburg which, when healed, left him with a permanent limp. Still, John dutifully went back to his regiment.
