### INFORMAL SESSION.

Austin, Texas, April 20, 1898.

At 10:30 a.m. the officers and representatives of the Department of Texas G. A. R., together with the ladies of the Department W. R. C., assembled at the Board of Trade Hall, where welcome to the Capital City of Texas was tendered them by the Hon. Jno. D. McCall, its distinguished Mayor, eloquent in sincerity, hospitality and good fellowship. Department Commander Ketchum responded in fitting and appropriate terms, expressing the appreciation of the veterans for the sentiments voiced by the mayor of the city of Austin.

On behalf of Jos. A. Mower Post No. 10, of Austin, Comrade J. W. Burke made some pleasant remarks.

Comrade Jno. Roch, of Gen. Sam Houston Post No. 55, responding to the call, delivered one of his characteristic addresses, teeming with wit, humor and feeling.

To the call for the Woman's Relief Corps, Mrs. E. G. Rust, of Houston, Department President, made some cheerful remarks appertaining to the Corps in Texas.

The Department Commander announced that a pleasant surprise was in waiting for the Encampment, and introduced Comrade H. C. Adler, of Terrell. Comrade Adler stated that a distinguished citizen of Texas, desiring to manifest his appreciation of our beloved order, had selected a Department banner as being appropriate. This elegant piece of workmanship was thereupon borne into the hall and deposited upon the platform amidst the cheers of all assembled. Comrade Adler then, in eloquent words, on behalf of Hon. E. H. R. Green, the railroad magnate of Terrell, presented this beautiful emblem to the Department Encampment of Texas.

Before the session closed the Department Commander received at the hands of a reporter, the news that President McKinley had just signed the Cuban resolu-

tion passed by Congress. A resolution was unanimously adopted that a telegram be sent to the President, stating that the Department of Texas, Grand Army of the Republic, in session assembled, commended his action and tendered him its sincere thanks for so promptly signing same.

The informal session then dismissed to convene in

### FIRST DAY--EVENING SESSION.

AUSTIN, TEXAS, April 22, 1898.

The 13th Annual Encampment, Department of Texas, Grand Army of the Republic, convened at 2 p. m. in Board of Trade Hall, Austin, Texas, and was opened in due form by Department Commander Ed. Ketchum.

Divine invocation was offered by the Department Chaplain, S. W. Patterson.

Comrades R. C. Bardenwerper and Paul LaFrance, of Jos. C. Mower Post No. 10, were appointed officer of the Day and Officer of the Guard, respectively.

The Department Commander delivered his annual address.

#### Comrades of the Grand Army:

On the 62nd anniversary of the battle that made Texas an independent Republic, we have elected to hold our thirteenth annual Department Encampment in the Capital City of the Empire State of the South.

In no city could our welcome be more hearty by the citizens extended and by none more highly appreciated than ourselves.

We meet in Fraternity, Charity and Loyalty, and

may these three great virtues be exemplified in our de-

The year just past has not been marked with any liberations.

great achievements by our order in this Department, though there has been added to our report two new Posts, San Jacinto No. 75, at LaPorte, in Harris county, and J. C. DeGress No. 76, at Fort Worth, in Tarrant county, bringing into our order 19 and 20 members respectively, while the reviving of Wainwright Post No. 72, at Alvin, Texas, may be considered again in the right

These Headquarters opened up correspondence with direction. several delinquent Posts through their members. swers were received from members of Farragut Post No. 28, at Cameron, also from members of Kilpatrick Post No. 40, at Belton, and Custer at Lamasco; all showing a willingness to keep up the touch of elbows, but complaining of hard times, scattered comrades and inabil-

ity to get members together.

From other Posts not revived, no answers were received to the letters written; perhaps the letters did not reach their destination, or if they did, the comrades receiving them had not the heart to write a letter that

could not be cheerful.

I can see but one way to deal with this matter, and that is in accordance with Paragraph 96, Section 4, Chapter 5, Article 1, of Rules and Regulations. They having been duly notified, and not having responded, their charters should be suspended or annulled, as therein provided; thus relieving this Department of the weight of dead timber unnecessarily born e upon the rolls.

This dropping out of Posts, comrades, plainly tells of the beginning of the end. The prologue of time is plainly telling us, now 37 years since many of us took up arms to earn our credentials for membership in this order, that the "tattoo" is sounding, that we should repair to our quarters and get them in order as the time is

not far distant when "taps" shall be sounded.

Concerning our grand auxiliary, the Woman's Reilef Corps, I shall be silent, save to say, God bless them and their good and loving work, as their Department President, Mrs. Maggie A. Rust, has a report and an excellent one to bring before you.

Of the Sons of Veterans, there has been one Camp

added to the organization in this state, this at Galveston, with a charter membership of 24, bearing the name of our lamented Past Department Commander and comrade, W. H. Sinclair, and it is growing and prosperous. I wish my comrades would pay more attention to this organization, as it is to take our places when we are mustered out, and we should see to it that the 'leaven of the old loaf shall pervade the new." In times such as these now passing, these young men, properly organized and equiped, can bear recollections of us and our powers into new fields and for as glorious a cause as was ours. See to it, comrades, when you go home that your boys form a Camp of the Sons of Veterans, then visit their Camp, help them through with their deliberations, and you will renew your youth for the time being watching as it were, your younger self performing over again the things you did in your camp life.

I have received a letter from Wm. B. Wilson, president of the society of the United States Military Telegraph Corps, requesting that I ask the sense of this Encampment on their appeal to the National Encampment at Cincinnati, in September next, for the admis-

sion of its members into our order.

Their claims are based upon honorable, efficient and important service rendered the government in our army

during the civil war.

While they did not plan campaigns and fight battles, yet amidst the roar of battle were found coolly advising the general commanding, of the battle's progress, or sending his orders to distant fields for cooperation.

The secrets of campaigns, yes of the Nation, were entrusted to them. They called for the Quartermaster's, the ordinance, the commissary and hospital supplies when needed, and by their zeal for our welfare rushed them forward. They have been recognized by Congress, in an act approved by President Cleveland, January 26th, 1897, authorizing the Secretary of War to issue to all survivors and representatives of those deceased, certificates of honorable service in the Military Telegraph Corps of the army of the United States, and I now ask this Encampment to take such action as it may deem fitting to place their claim before the next National Encampment.

The attention of this Department is called to an effort now being made throughout our country by the great transportation companies, by the great damp is asked to lend a aid which the Grand Army is asked to lend a hand, asking Congress to enact the anti-scalping bill; hand, asking companies shall be protected in round so that railroad companies thus quaranteeing our so that ramound the scalper, thus guaranteeing ourselves trip service from the scalper, thus guaranteeing ourselves

lower rates to these and other like gatherings. Regarding the matter of a Soldiers Home at Cor-

pus Christi, concerning which a resolution was adopted at our 12th annual Encampment at Houston, instructing our representatives to introduce the subject thereat, will state, that your delegation to that Encampment met a petition signed by the governor, all of the judges of various courts, the bishops and other clergy of South Carolina, the Board of Trade and Cotton Exchange and Chamber of Commerce, of Charleston, S.C., also the many distinguished personages of that city and state, asking the co-operation of that Encampment with the above named citizens and their petition before congress, for a bill authorizing the building of a Sanitarium on the site occupied by Castle Pinckney in Charleston Harbor, to be named after the gallant defender of Fort Sumpter, Major Anderson, for the use of old federal soldiers. The action on this subject and the address of Dr. Bays, to the Encampment, consumed the afternoon of Friday, the second and last day of the deliberations, thus throwing the closing work of the Encampment into the evening hours, and dwarfing anything that Texas could offer in its behalf in favor of Corpus Christi, hence your delegation took no action.

When I assumed command of this Department at Houston, a year ago, I found that our liabilities amounted to \$131.67. This with the general depression in business, which affected myself as well as the balance of us, prevented me from visiting the Posts of this Department, and I hope therefore in the selection of my successor, you may choose one better able to travel than has been

myself.

One of the assets borne upon the report of the Department Quartermaster is a banner valued at \$54.50. suggest that this asset be dropped on "abstract L," or by some other means, and some provision be made for a new banner to designate these Headquarters, both at home and abroad.

I have sometimes thought that the absence from these Encampments on the part of some of our Past Department Commanders may have been caused by the lukewarm interest taken by some of our Posts and Post officers in their duties touching Headquarters, for how can a Department officer feel encouraged in the performance of his duties when many show so little appreciation.

I must remind you that every Post Commander takes a solemn obligation that he will see that all reports shall, during his term of office, be forwarded promptly, and should his Post disband during said term of office, that he will wind up its affairs honorably, forwarding all books of record, papers, Rituals and Charter, to the Department Headquarters. How well this obligation has been kept I will refer you to the report of the Assistant Adjutant General. This disregard of solemn obligations, this lack of thoughtfulness on the part of officers who become responsible for the welfare of their comrades and their duties to this organization, is well calculated to dampen the ardor of comrades as well as the future interest of Post Commanders and their faithfu assistants.

I do not make these utterances in a spirit of reproach or fault finding, but like the keepers of ancient assemblies who stuck pins in the congregation to keep it awake, so I am trying to call the delinquents back to their sense of duty, that my successor shall profit, as well as the Department, from my having served as Commander during the past year.

I must not close without thanking the officers of those Posts who have reported promptly and have thus always sustained and helped Headquarters. I am also under lasting obligations to the comrades who composed my official family, for without their assistance my administration would have been barren of results. While these have done only their duty I can assure you and them, it has been both refreshing and helpful, and now, comrades, before I forget, I must thank you for the honor you conferred on me one year ago. While I have done but little if any, for the good of the order, I tried to do the best I could, and I promise you that my membership in the Department Encampment shall not expire with my term of office, for I shall remain an active Grand Army man, ever loyal to my comrades and my country.

Three Posts have been gained, viz: Wainwright, No. 72, Alvin, organized June, 1897, San Jacinto Post No. 75, LaPorte, organized September 24, 1897, and J. C. DeGress Post No. 46, organized November 29, J. C. Decree 1897. The two lost were Belknap No. 37, of San Antonio, and Wesley Merritt No. 69, of San Angelo, whose charter was surrendered previous to my term.

The following Posts rendered no reports, viz: Sheridan No. 25, Farragut No. 28, Custer No. 32, Kilpatrick No. 40, McKenzie No. 46, Crook No. 49, Sherman No. 51, Dick Yates No. 59, Crockett No. 70, Hooker No. 73. The aggregate membership of these Posts as rendered to the National Headquarters was 131, upon which per capita tax was paid, as required by Rules and Regulations. Of these, Sheridan No. 25 has rendered no report or per capita tax for two years, Farragut No. 28, one year, Kilpatrick No 40, two years, Crook No. 49, one and one-half years, Sherman No. 51, two years, Dick Yates No. 59, two years. The Assistant Quartermaster-General's books indicate that Hooker No. 73 was suspended in 1894, but, unfortunately, has been continuously rendered upon the returns to National Headquarters, with a roll of 12 members. I recommend that the Council of Administration take proper steps, looking to their suspension or disbandment, as required by Rules and Regulations.

It seems to be a twice-told tale to refer to the matter of reports. My predecessors have suffered from dilatory, incomplete and incorrect reports rendered by many Posts. My successors may experience the same annoyance. I am sure I have acquired many gray hairs wrestling with this burden.

I concur in the recommendation of Adjutant-General Burmester, who has given the subject serious and careful thought, and commend the same to our representatives at the next National Encampment at Cincinnati, that it may be brought to the consideration of the Encampment. The following plan is outlined by Adjutant-General Burmester:

That all Post officers who are required by Rules and Regulations to make report, i.e., Adjutant, Quartermaster, Surgeon and Chaplain, should make out annual reports at the expiration of their term of office, and deliver them to the Post Commander, whose duty it shall be to see that they are so prepared and delivered These reports are to be presented to the officer or comrade detailed to install the new Post officers at the beginning of the year, together with the per capita

### REPORT OF DEPARTMENT INSPECTOR.

STEPHENSVILLE, TEXAS, April 16, 1898.

Col. Frank L. Kirk, Assistant Adjutant-General, Department of Texas, G. A. R.:

DEAR SIR AND COMRADE:—I have the honor to present herewith the consolidated report of the inspection of the Posts of this Department.

Your published roster of the Posts of this Depart-

ment shows 43 Posts carried on the rolls.

Of this number thirty have forwarded to me inspection reports. The first received was Post 5, which came into my hands on Nov. 13, 1897. The last was received April 12, 1898. Seven reports were not received until after the time prescribed by General Orders No. 2 from National Headquarters, for making a summary of the

consolidated report to the Inspector-General.

If it is within my province to make suggestions, or recommendations, for what I deem to be for the good of

the Department, I would recommend,

That where it is feasible, and practicable, without expense to the Department, or Posts, that Assistant Inspectors be assigned to other Posts than their own. This can be done in large cities where there are two or more Posts; and in near adjoining towns.

2. That the Department take some action in regard to Posts carried on its roster which have virtually disbanded, so as to relieve the Department from the per capita tax. It will be an easy matter to reinstate them

again if the Post shows signs of life.

3. That the Department take some action in regard to the clause in General Orders No. 3 from National Headquarters, promulgated at Omaha, Nov. 14th, 1896, relating to Departments allowing Posts to divide their membership into two classes, to-wit: resident and nonresident members; in other words, allowing them to form pickets with a sergeant in charge. I am of the opinion that this plan will not meet with favor by country Posts whose membership is scattered. (My own Post is anxious to try the plan.)

In conclusion I desire to return my thanks, and gratitude to Commander Ed. Ketchum for the honor conferred upon me, in selecting me from among the able and probably better qualified material at his hands for Department Inspector, and to both him and yourself for the courteous treatment I have always received at your hands.

I am only sorry that it is impossible for me to be present with you and the boys on this occasion, this being the first Encampment that I have missed since I joined the order in this State. Respectfully submitted.

In respectfully submitting this report, I beg to add that I feel I have been direlect in my duties, because I

have been discouraged.

When we consider the fact that the perpetuation of this union, the glory, the grandeur and strength of this great nation, is entirely due to the sacrifice of life and blood of the ex-Union soldiers of 1861-5, and that congress by its acts, in consideration of these sacrifices, made it a law that the survivors shall have part in the government of our country in preference to all others, yet this law and our claims are entirely disregarded. Patriotism and loyalty have no consideration, and men who were the most prominent in arms against our flag and in politics are chosen by our comrade President, in preference to the ex-Union soldier and Grand Army man whose patriotism and loyalty was put to the cru-

cible test, and whose ability, integrity and worthiness

was beyond question.

Our organization is the only one in existence which is founded solely on its love for our country and is therefore the strong right arm of our government, but as we are ignored as our country's defenders, and as the promoters of loyalty and patriotism, and recognized only as to our political standing if we have any, we must therefore content ourselves with the exercise of charity, and in asking the question, "Does any one know of a deserving soldier or sailor needing our assistance" and if such we find, alleviate their sufferings as best we can-now seems to be our only mission.

## REPORT OF DEPARTMENT CHAPLAIN.

Austin, Texas, April 21, 1898.

Gen. Ed. Ketchum, Commander of Texas G. A. R., Austin, Texas:

In compliance with the rules governing this department, I have the honor of submitting the following

report:

Since our last encampment at Houston, Texas, our comrade and Department Chaplain, Rev. W. J. Bassett, who preceded your present Department Chaplain, has passed from life to the eternal city above. He has gone to the city of the New Jerusalem, where funeral marches are never played. Gone to dwell in the city not made with hands. Comrades, there is but a little time that separates our absence. Let us be prepared to answer to the roll call on high.

The following Posts have submitted to me the re-

ports of Memorial and Decoration Days:

Randall Post No. 45, Weatherford.—We had our Memorial Sabbath service in the M. E. Church, South.

There was a sermon preached, and 37 comrades were present. The Memorial Day service was attended by 3500 people, five public schools participating. Sixtyfour Confederate soldiers who wore the gray joined the boys who wore the blue to scatter flowers on the graves of the nation's dead. Much of the success of the Memorial Day was due to the earnest efforts of the Post Commander, who succeeded in getting the citizens, the public schools and the Confederate and Federal soldiers to co-

operate together.

I submit the following letter in the report from Ord Post No. 3, San Antonio; "Memorial Day falling this year on Sunday, the preaching day was observed. The exercises were held in the National Cemetery, and each one of the 1157 graves therein were marked by a small flag and a handful of flowers by Ord W. R. C. No. 5. The orator of the day was General Paul Vandervoort, Past Commander in Chief of the G. A. R. The military from Fort Sam Houston, cavalry, artillery and infantry, Ord Post and ex-Union soldiers, Ord Camp No. 49, Sons of Veterans, and Ord W. R. C. No. 5, with the children, took part in the parade. The volley over the Memorial grave (comrade E. C. Imlay's) was fired by a company of the 18th infantry, followed by a salute of 21 guns by the artillery, and tap by the bugle. Memorial Day is regarded by the citizens as one of the events of the year. The attendance was good. For fifteen years Ord Post has observed the day with becoming ceremonies, but rarely has it been a more pronounced success than on this occasion. The exercises were continued at night in our hall under the auspices of the W. R. C. Submitted in F., C. and L.

Kit Carson Post No. 74, Waco.—This Post observed Memorial Sabbath service. The G. A.R., W. R. C. and Sons of Veterans, attending. About 300 of the blue and gray joined in the Decoration service. The orator of the day was the son of a veteran, Wm. H. Atwell. The Post in answering the question, "How to make the Memorial services more impressive?" answers, "By having the Texas legislature pass a bill making May 30th a legal holiday for Texas."

Crawford Post No. 19, El Paso.—Reports both Memorial Sabbath and Memorial Day services. One enjoyable feature of the day was good music. There were 30 soldiers' and sailors' graves decorated. This

Post owns its own cemetery lot. Twelve stones were ordered from the War Department to be placed at the

unmarked graves.

Holcomb Post No. 57, Mason.—Decoration Day was observed. Nine of our soldiers' graves were decorated. All the comrades for twenty miles came together to participate in the Memorial Day exercises.

Travis Post No. 66, Abilene.—The report is almost

a blank. Three unmarked graves.

Houston Post No. 55, Dublin.—The Sabbath Day Memorial service was duly observed. There were 100 persons attended Memorial Day service. The orations were by a veteran and the son of a veteran. The Post

reports a good time and profitable service.

Custer Post No. 32, Lamasco. - The Memorial Day was duly observed. Post on Decoration Day remembered their comrades' graves. There were five cemeteries in which lay the fallen comrades, and the graves of all were strewn with flowers. There were five unmarked graves reported. The orator of the day was an ex-Confederate.

Burnside Post No. 56, Springtown .-- Memorial Sabbath Day found 28 of the comrades in line. The sermon was preached by a veteran. Two hundred persons were present on Decoration Day. The oration was by a

veteran.

John A. Dix Post No. 11, and George H. Thomas Post No. 6, both in Dallas, and the two W. R. C.'s and Sons of Veterans joined together in celebrating Memorial Day. The Memorial sermon was preached by the Department Chaplain, S. W. Patterson, in the Exposition Park Presbyterian church. The church was neatly decorated with flags, bunting and flowers; the singing was by the congregation. The services throughout were very impressive. Over 70 comrades were present, attended with about the same number from the W. R. C. and Sons of Veterans. Decoration Day was very impressive and solemn. We owe much to the W. R. C. for their presence and help. Fifty-three graves were decorated. Several hundred people attended the services. The music was fine, the orations grand, and the feeling among all very tender. The Memorial services closed by the recital of an extract from President Lincoln's address at Gettysburg, Nov. 19th, 1863.

Lyon Post No. 5, Denison.—The Post Chaplain

writes: "We had a very satisfactory and impressive service. Sixteen hundred people were present at the Memorial day service. Two schools and some 90 pupils were present. One hundred and sixteen soldiers' and sailors' graves were decorated. Sixty-five unmarked graves were reported. The services throughout were a fit token of how the dead comrades are held in memory by the veterans and the noble W. R. C.

Parmly Post No. 4, Fort Worth.—We had forty comrades in line. The W. R. C. participated in all the services. Fifty-five graves were decorated. Four of our comrades are reported buried in the potter's field. Twenty-eight graves are unmarked by proper headstones. The orator on the occasion was the son of a

veteran.

Hancock Post No. 2, Galveston.—The services of both days were duly observed. The exercises on Memorial day were participated in by some forty persons. There were twenty-eight comrades in line. Thirty

graves were strewn with flowers.

E. J. Davis Post No. 54, Corpus Christi.—We had our Memorial Day. Thirty-five graves were decorated. The orator of the day was Mrs. W. T. Carter, the wife of a member of the Post. This is the only woman orator in the reports of the different Posts. The near future in all probability will raise up more of these noble women orators to perpetuate the history of the G. A. R. It is the prediction of your humble servant that the power behind the throne will some day be on the throne.

McClellan Post No. 9, Houston.—From the press reports and a letter from the Post Chaplain, Dr. D. W. Bartlett, it is safe to say that never before has Memorial Day been so generally observed. In response to the invitation of George B. McClellan Post there was a more general outpouring of citizens than any previous year. The Confederate veterans, Texas Volunteer Guard, Woodmen of the World, the W. R. C. and other organizations, formed in line with the cavalry and artillery, making a grand parade. Commander Norton's address was indeed patriotic, cheering and pathetic. The kind words spoken, the tender feelings of love manifest, will never be forgotten. The music was inspiring, cheering many a heart that throbbed with pain. The earnest and eloquent prayer and the tribute paid the dead comrades by Rev. G. W. Story, was very touch-

"In your names, my comrades, I scatter these memorial flowers upon this mound, which represents the graves of those who died in the sacred cause of our country. Our floral tribute shall wither; let the tender fraternal love for which it stands endure until the touch of death shall chill the warm pulse-beat of our own hearts." The oration by J. W. Jones was very fine. The artillery fired a salute of three guns to the dead. The Confederates and citizens generally joined in a petition to the legislature to declare May 30th a legal holiday.

It is to be very much regretted that only 15 Posts reported memorial sevices out of 44 Posts. Let me in closing this report, urge upon all Post Chaplains to give

a rousing report for 1898.

I wish in closing this report to thank the Encampment which met at Houston last year for honoring me with the office of Department Chaplain; you did it in my absence, but I cheerfully accepted the honor and wish my Commander and all comrades, peace, purity and long life.

I wish to be present and again urge the importance of securing favorable action by the National Encampment in the matter of establishing a Soldier's Home here. The matter seems not to have been introduced at the meeting at Buffalo. Our Representatives did not attend, and those members of our Department who were there did not see fit to bring the matter up. I think it clearly the duty of this Encampment to again renew the action of last year and see to it that the matter is vigorously pushed at the next meeting of the National Encampment. Comrades, every condition of justice and expediency demand that a Branch Home be located somewhere in the far South.

If we move earnestly in this matter I believe we can secure at least a small branch here. The petition is in the hands of the committee on military affairs in Congress, and I have the promise of Congressmen Kleberg and Hawley to do all they can to secure favorable action. The Assistant Adjutant-General of the Department of Louisiana and Mississippi assure me that their Departments will co-operate with us. Other Departments will also assist, while none can oppose us on any reasonable grounds. We do not antagonize them, but only ask justice for the old soldier living in the far South.

The number of deaths will probably be reported by the Adjutant-General. The U.S. Pension Department is asking for reports from the pensioners in regard to the marriage of the pensioner, the number of children and the age of each. This is probably to facilitate the claims for the widow's pensions.

The Grand Army of the Republic should collect and keep a record of these questions and answers in a separate book for that purpose. There are many members of the G. A. R. who do not draw pensions, and in case of death the widow will be entitled to pension. The pen-

sion department ask the following questions:

"1st. Are you married? If so, please state your wife's full name and her maiden name.

"2nd. When, where and by whom were you married?

"3rd. What record of marriage exists?

4th. Were you previously married? If so, please state the name of your former wife and the date and place of death or divorce.

"5th. Have you any children? If so, please state

their names and the dates of their birth?"

These are the questions that have to be answered when a widow applies for pension. They can be more readily answered during the lifetime of the soldier, and each Post should make a record of it. It often takes a long time for a widow to complete her claim, but if these questions are answered during the lifetime of a soldier, she will get her pension much sooner and with less ex-Respectfully submitted in F., C. & L.,
