

FIRST DAY.

Journal of the proceedings of the Nineteenth Annual Encampment of the Grand Army of the Republic, Department of Texas, held at San Antonio, Texas, April 21, 22 and 23, 1904.

In accordance with General Order No. 10, the Council of Administration and the Credential Committee met at the Menger Hotel at 9 o'clock a. m. April 21, 1904, and made the following report:

As per program, at 10 o'clock a. m., the Grand Officers and delegates, headed by the band of the Twenty-sixth United States Infantry, and escorted by the members of E. O. C. Ord Post No. 3, G. A. R. of San Antonio, formed line and marched to the Empire Opera House on Houston street, where the Encampment was formally received and called to order by Post Commander L. L. Whitaker of Ord Post, who introduced the Hon. Vories P. Brown, who, in the name of the Mayor and City Council of the city of San Antonio, welcomed the officers and delegates of the Encampment in an eloquent and patriotic speech.

Department Commander Bolton replied in a few well chosen words and introduced Post Commander L. L. Whitaker, who, in his jovial and characteristic manner, made all feel at home and glad they had come.

Colonel D. E. Groove, a gallant ex-Confederate of Dallas, was then called on and introduced by Post Department Commander R. M. Moore, and made a most interesting and patriotic talk along the lines of the fraternity and good feeling that existed between those who wore the Blue and those who wore the Gray. "The men who met in battle shock," he said, "were now joined together under one flag and cemented, as it were, by the blood of mutual comrades shed upon many a hard fought field." His remarks were loudly applauded. Col. R. M. Moore of Ord Post No. 3 then followed, rejoicing over the fraternal feeling that existed between the old soldiers of both sides.

Mrs. Sarah D. Winans of Troy, Ohio, the National President of the W. R. C., was then introduced by Commander Bolton and made a very feeling speech. She told of the organization and work of the W. R. C. and stated that they now had a membership of over 40,000, and since 1883 had disbursed in relief and charity the sum of \$2,504,365.23.

Mrs. Jennie Wright of Troy, Ohio, the National Secretary of the W. R. C., also addressed the Encampment. She spoke briefly, but to the point. Her remarks were listened to with attention.

Mrs. Julia Tabor, Department President of the W. R. C., was then introduced. Her address was short, but interesting. She was followed by the Senior Vice President of the State W. R. C., Mrs. Byron R. Underhill, who spoke clearly and in a very interesting manner, showing herself to be well posted in all that pertained to the welfare of the G. A. R. and W. R. C. of Texas.

Mrs. Vicentitia C. Dowling, Junior Vice President of the Department, was then introduced by Commander Bolton. She made one of her characteristic and enthusiastic talks to the Boys in Blue and the Boys in Gray and the Ladies of the W. R. C.

She was followed by Mrs. Delia B. Boothroyd, whose remarks were pleasing and interesting.

This concluded the opening ceremonies and Commander Bolton announced that the meeting would now close by the singing of a verse of the National hymn, "America," by the audience, all arising. This was done and thus the ceremonies ended for the morning.

The following Department Officers were present at the formal opening of the Nineteenth Annual Encampment: John H. Bolton, Department Commander; Rev. T. K. Crowley, Department Chaplain; Dr. L. L. Whitaker, Medical Director; A. I. Lockwood, Assistant Adjutant General; E. A. Russell, Department Inspector; W. H. Harvey, Chief Mustering Officer; T. M. Wright and P. B. Sprague, members of Council of Administration, and James S. Dunlap, member Committee on Pensions.

Guard duty was performed by Alvin Mosher of Ord Post No. 3 of San Antonio, officer of the day.

Comrade A. H. Moeglin, of Ord Post No. 3 San Antonio, officer of the guard.

Adjournment was had until 2 o'clock p. m.

Odd Fellows' Hall, 2 o'clock p. m., April 21, 1904.—The Encampment was called to order by Department Commander J. H. Bolton, who instructed Comrade Mosher, officer of the day, to post his guard at the entrance to the Encampment and to demand the countersign from all present.

The officer of the day reported that all present had the countersign and were members of the Grand Army of the Republic.

Commander Bolton thereupon called upon the Department Chaplain, the Rev. T. K. Crowley, to invoke the divine blessing upon the Comrades there assembled, which the reverend gentleman proceeded to do in a most feeling and eloquent prayer to the "Great Commander" of us all, to "guide us with wisdom and make our annual gathering one of great good, not only to the Comrades here assembled, but to the Comrades everywhere, and to the whole people of our great and loved country.

Commander Bolton now announced that the Nineteenth Annual Encampment of the Grand Army of the Republic, Department of Texas, was open in due form and ready for the transaction of such business as may be properly brought before it.

The "Roll of Delegates" was then called and forty-eight answered to their names.

REPORT OF DEPARTMENT COMMANDER.

San Antonio, Texas, April 21, 1904.

Comrades: It becomes my duty to present to you a report of the work performed by me during the past year in the office you so kindly and unanimously elected me to at Dallas one year ago. I fully appreciate the gift you bestowed upon me, because it is a coveted one by all Grand Army men, knowing as I do that in the short span of life left to those who went forth in the early sixties to battle for their country, it can only fall to the lot of a few to receive the honor to fill the most exalted station in the Department before we all are mustered out of this world. My duties have been much of a formal character, there being no occasion presented to me during the past year calling for any extraordinary function. In regard to the several requirements laid upon me at the Encampment at Dallas, I will first report upon the special funds placed in my hands by my predecessor.

FUNDS.

Department Commander C. C. Haskell placed in my hands on retiring from office four hundred and ninety-eight dollars and eight cents (\$498.08), which, by resolution of the Encampment, should only be paid out under the instructions received from the Commander-in-Chief. Shortly after my induction into office, an application was made to me by a Comrade, who formerly lived at Galveston, for relief to the amount of five hundred dollars. which, after careful examination, I forwarded to the Commanderin-Chief for his action, and same was returned to me not approved. I also received an application for relief for an old Comrade at Waco, presented through two ladies formerly of the Woman's Relief Corps of that city. I referred the same to the Commander there, and upon receipt of his report I forwarded all Post at Galveston, made application for one hundred dollars for their relief fund. The grounds for their request appearing adequate, I recommended same for approval, which was granted and the amount forwarded to Colonel Clawson, Commander of the Post, who acknowledged the receipt of same, leaving three hundred and ninety-eight dollars and eight cents (\$398.08) in my hands to be transferred to my successor. Past Department Commander Charles B. Peck transferred to me five hundred and eleven dollars and ninety-three cents (\$511.93), to be held subject to the order of the Commander-in-Chief. At the National Encampment held at San Francisco, Cal., last August, it was resolved that this Fund be transferred to the National President of the Woman's Relief Corps, and in obedience to order of General John C. Black, I transmitted the same to Mrs. Sarah D. Winans, National President, receiving her receipt for same.

MEMORIIAL DAY.


From the public press, I gather, that this day was fittingly observed by all the Posts in the Department, and in many places where no Post exists, Comrades did not forget those "who had gone before them," but touchingly and reverently decorated the graves with beautiful flowers and placed the flag that they, while living loved so well, over their final resting place. The Department Chaplain will report to you more particularly how well this day was observed by the several Posts.

FLAG DAY.

I believe that June 14th of last year was generally observed by the Posts in this Department with appropriate ceremonies. General Order No. 4 was issued with this intent. It has been my special privilege to assist in raising "Old Glory" over two public school buildings in this city, and one over a public school in the county. Each time we went forth on this pleasant duty the Comrades and ladies of the Woman's Relief Corps joined hands in making the occasion profitable to our youth; and the manner in which these beautiful flags were received by the teachers and scholars was very gratifying. The Department is indebted to Mrs. Kate D. Jones, National Patriotic Instructor of the Woman's Relief Corps, for the gift of these flags.

NEW POSTS.

I regret that it was not my good fortune to organize a new Post during the past year. Comrade Adler, at Victoria, has been doing

quarters were held at "The Grand," and the ladies of the W. R. C. of Texas shared our parlor and were lavish in their floral decorations of the room. Eighteen Comrades from Texas were in line of march, and the "Long Horns" were received with applause all along the line.

LEGISLATION.

The National Encampment adopted a Service Pension Bill granting \$12 per month to all soldiers of the Civil War, who served ninety days and were honorably discharged, on arriving at the age of 62 years upon their applying for same; and a like pension to the widow of said soldier—providing she married him prior to June 27th, 1890. This bill is before Congress, but since the ruling of the Commissioner of Pensions on age disabilities, lately promulgated, it is doubtful if it will pass.

ORDERS.

General Orders and Special Orders have been issued during the year and distributed to the several Posts.

WOMAN'S RELIEF CORPS.

I cannot afford to complete my report without a word of commendation to our noble auxiliary, the Woman's Relief Corps. As we grow in years more feeble and helpless, they, I know, will in the future, as in the past, give that timely assistance which will bring much comfort to us in our declining years. I would urge upon every Comrade to render them all the encouragement possible to keep their Order up to the standard. Every Post should have a Woman's Relief Corps. If your Post is without one, organize at once. You will soon see the benefit you will derive from it—socially, patriotically, and fraternally.

DEATHS.

We are called upon to mourn the loss of twenty-two Comrades since our last Encampment, who have gone to their happy homes above. These noble men have shown by their membership in one of the grandest organizations on the face of the earth that not sociability or political influence alone held them in our Order, but a spirit of charity and loyalty, to stand by those who stood by

them, who now need a helping hand, had something to do with their retaining their membership with us, and we should revere their memory and try to emulate their virtues.

In my work in the Department during the past year, I have been ably assisted by the Department Officers, the Council of been ably assisted by the Department of my personal staff, as well as Administration, and members of my personal staff, as well as by many Comrades throughout the Department, to one and all of whom I am deeply indebted and tender them my sincere thanks.

FORT WORTH, TEXAS, April 20, 1904.

Comrades of the Department of Texas, G. A. R., in Session Nineteenth Annual Encampment, San Antonio, Texas:

It affords me much pleasure to express my thanks to the Comrades for the honors bestowed upon me at your last Annual Encampment at Dallas, April, 1903, as your Junior Vice Department Commander, and exceedingly regret my inability to meet with you on the nineteenth annual gathering in the beautiful city of San Antonio, where the exalted heroes who fought and died at the revered Alamo for the independence of our grand old Texas, lie sleeping quietly beneath the green sod and beautiful flowers of spring time. Let us ever cherish their memory for their noble deeds and self-sacrifices, as well as our Comrades of the Grand Army, who have gone before and answered the roll call beyond the silent river. Circumstances have been such during my official year that 7I have been unable to personally visit any of the Posts. but often meet Comrades from different portions of our State in passing through our city. From them I have had many a word of good cheer for the present and future welfare of the Grand Army.

Quite a number of Comrades have come to Fort Worth the past year from the Northern States, attracted by our rapid growth, and will make this their home. John A. Logan Post, No. 23, of Denton, and W. T. Sherman Post, No. 51, of Granbury, have made no returns during the past George A. Custer Post, No. 32, surrendered its charter on August 13, 1903. On December 6, 1903, John A. Dix Post. No. 11, and George H. Thomas Post, No. 6, of Dallas, adopted a joint resolution of consolidation; surrendered their respective charters and applied for a new charter, under the name of Richard J. Oglesby Post No. 6, of Dallas, which was promptly for-

warded to them from these headquarters. By the consolidation of these two Posts, while the Department did not lose in membership, it did lose one Post, which, added to the others enumerated. makes the total deficit of four Posts.

The suspensions this year were only 64, as against 111 the preceding year, which is surely a cause for congratulation.

Several of the Posts of the Department are extremely weak, numerically, their membership ranging from five to ten members in good standing. The Commanders of these Posts are deserving

of great credit for their patriotic and unselfish work in keeping alive their organizations. With so small a membership it is very hard to keep up an interest in their Posts, and frequently they are only kept in line by the personal sacrifices of the officers.

DEATHS.

During the past year Death has been busy and has invaded the portals of many of our Posts, striking from the ranks many a loved Comrade and brave Soldier. The total number of deaths reported up to December 31, 1903, amount to twenty-two, as follows:

In conclusion, I wish to thank every Post Commander and Adjutant in the Department for their uniform courteous treatment. and I shall retire from office with the best of feeling toward every Comrade in the Department, and to you, Commander, I wish to return my sincere thanks for the honor conferred upon me by your appointment, and for your unvarying kindness and assistance during my term of office. I have endeavored to do my best for the interest of the Grand Army of the Republic, and to reflect no discredit upon your administration.



The Committee on Pensions to be appointed by the Department Commander-elect at his leisure.

A committee was then appointed to notify the ladies of the W. R. C. that the Encampment of the G. A. R. was ready for the Installation of officers, and would like to have a joint Installation on Saturday morning at 10 o'clock at the rooms of the Relief Corps, if agreeable. The committee reported that the W. R. C. would be ready for a joint Installation at the time and place selected.

The selection of the place to hold the next annual Encampment was left to the Council of Administration.

The Encampment was adjourned until time for Installation of officers, Saturday, April 23, at 10 o'clock a. m.

On the night of the 22nd of April a Mexican supper and ball-was given to the officers and delegates and invited guests at Turner Hall, at which there was a large gathering, and all enjoyed the dancing and participated in the excellent supper served.

THIRD DAY.

At the appointed hour, 10 o'clock a. m., April 23rd, the Encampment met at the headquarters of the Woman's Relief Corps, the K. of P. Hall, and was called to order by Commander Bolton, who thanked the Comrades, one and all, for their assistance during the year of his administration, and also the ladies of the Woman's Relief Corps. He bespoke the same aid and support for his successor.

Mr. Commander and Comrades:

I have had the great honor and the pleasure of being appointed to bring you the greetings of the fifteenth Department convention of the Woman's Relief Corps of Texas, and to give you a hearty welcome to the beautiful and historic Alamo City.

It is indeed a pleasure that thrills one through and through to be able to gaze upon such a noble army of faces—indeed a Grand Army—and feel that these are the boys in blue who fought our battles, won our victories and helped form the mighty Republic of which we are all members. The Woman's Relief Corps are proud to be called an auxiliary to such a body. We are called a Relief Corps, and we glory in the mission that will permit us to relieve the wants of the poor soldier, make his path brighter and his bed more restful, as he journeys through life. Many were the expressions of appreciation of a woman's tender care heard on the battle fields during the four years of strife, and Comrades we are here today to extend to you that same sympathy, that same tenderness and that same helpfulness that we may still receive the appreciation and affection which we know you bear for our Corps.

Do you know that you are really noble examples of manhood: you are brave and fearless, and we are satisfied that you could still render a good account of yourselves, were you called upon

to do so. But you never will be, for our sons are here to sustain the reputation you have made, and will do it faithfully. When we think of all the trials, perils, dangers and hardships that it has been your lot to pass through, our grateful thanks are due to Almighty God for having so well preserved you. We can make our lives sublime,
And departing, leave behind us
Footprints on the sands of time.

Comrade Taylor was born in Lansingburg, New York, sixty-two years ago. He enlisted April 19th, 1861, as a private in Company E, Third Ohio Infantry, and was mustered out as Captain, Company I of the same regiment. He immediately re-entered the service and was an officer in the Signal Corps, U. S. A., under General George H. Thomas; discharged therefrom May 1st, 1866, at Houston, Texas.

He was a charter member and organized the George B. Mc-Clellan Post, No. 9, Department of Texas, G. A. R., December 10th, 1885. He was Post Commander from 1885 to 1887, and Adjutant of the Post from 1887 to 1890, and was Department Commander of Texas for the year 1890.

He has been a resident of Houston for more than thirty years, was beloved by those who knew him, and respected by all for his fine business qualities and his sterling integrity.

Some years ago he confided to his comrades that the flag, presented by the women of the town in which his company was raised, was in his possession, and he desired that it be buried with him, which request was duly complied with, and his mortal remains enshrouded in the flag he followed repose in Glenwood

Cemetery, Houston, Texas.

IN MEMORIAM.

Again the Department of Texas is called upon to mourn the loss of a valued comrade, Comrade Dr. David Mackay, Past Assistant Surgeon General of this Department, and Past Surgeon General of the Grand Army of the Republic, died at his home, Dallas, Texas, Wednesday, March 23, 1904.

We mourn his loss, but he is enshrined in the hearts of his comrades. Fraternal, benevolent, loveable, honest and true, he possessed what he so richly deserved, the perfect trust, esteem and love of all who knew him; his face the index of his soul, showed him free from any unworthy or selfish motive or aim in life, and his grand character and frank fraternal manner endeared him to us all. He was the pure and staunch patriot, the light of the camp fire, the life of the Post room, and the joy of the Encampment; his light has gone out, but he will ever hold the warmest place in our hearts and will ever be to us the endeared and cherished comrade.

He was born in Glasgow, Scotland, seventy-one years ago. In 1855 he enlisted in the English navy as surgeon on a war ship that saw service in the Crimean war. After the close of the war he came to America, receiving his M. D. from the Hygeo-Therapeutical College in 1861. When the war between the States commenced he was commissioned Surgeon of the Seventy-ninth Regiment. New York Volunteer Infantry (Highlanders), and served with that organization until the close of the war, when he was honorably mustered out at Brownsville, Texas. He settled in New Orleans and was Surgeon of the Marine Hospital, and later city physician, and did noble service during the yellow fever scourge. Removing to Dallas he was given supervision of

the free schools in Dallas and sixteen other counties. Under President Harrison he was made a member of the Board of Pension Examiners, and has been a member ever since.

His name has been transferred to the "Roll of the Dead," but his lofty patriotism, his good deeds and splendid services as soldier, citizen, official and comrade will ever live and be kept green in our hearts and memories while life shall last.

To his widow and family we tender our sincere sympathy and condolence, and may He who doeth all things well, give them consolation in this hour of affliction and bereavement.
