DEPARTMENT OF TEXAS GRAND ARMY OF THE REPUBLIC, SAN ANTONIO, TEXAS MAY 25th, 1913

The open session was called to order at 10 o'clock a. m. by Comrade Alvin Moser, Commander of E. O. C. Ord Post No. 3, in the Odd Fellows Hall. After a brief address Comrade Moser turned the meeting over to the Department. Dept. Commander E. P. Brown called the audience to their feet and Dept. Chaplain Rev. B. F. Cavens offered up a fervent prayer. The national song "America", was sung with enthusiasm by the audience composed of ladies of the W. R. C. and of the G. A. R., Comrades, Sons and Daughters of Veterans, filling the beautiful and commodious hall to its capacity. The Hon. Edward Steves, Mayor of San Antonio, was introduced and welcomed the Grand Army and Woman's Relief Corps in the following patriotic and well chosen words:

ADDRESS OF MAYOR EDWARD STEVES.

Grand Army of the Republic; Mr. Chairman, Gentlemen:

As Mayor of the City of San Antonio, in behalf of each and every one of its citizens, I bid you welcome. It is an honor to have you with us, that we appreciate, a pleasure we shall try to deserve and one we hope to have many times in the future.

We are all proud and glad today, that the Stars and Stripes floats over us, North and South, an undivided nation, the greatest on earth. We love and revere the veterans of the war in which you gentlemen fought on the one side, and other equally good and brave men on the other, each for what they thought right. We San Antonians feel that we can appreciate as few others can, the qualities of bravery and devotion to a cause, having as we have, constantly before us, the mute evidence of another struggle, in which a mere handful of brave men, Crockett, Travis, Bowie and a hundred and eighty-four others, consecrated themselves to the cause of freedom for this great State of Texas, from the rule of Mexico. Whenever we are visited by men of these qualities, we are glad. You will always find a warm welcome here; you need not stand on ceremony—you are always invited. I now turn the city over to you.

Commander Brown, Past Dept. Commander W. F. Conner, L. L. Whitaker and Dept. Chaplain B. F. Cavens also addressed the convention. Mrs. Mabel Mussey Bates, representing the Daughters of the Confederacy and the D. A. R., presented the Department with a beautiful bouquet of white roses. Her address was full of patriotic sentiment, and was well received by the audience. Ladies of the W. R. C. and Ladies of the G. A. R. presented the Department with magnificent bouquets of roses. The open meeting was then adjourned and the regular order of business was taken up.

Comrades Robt. McCormick, A. I. Lockwood and E. J. Kilmer were appointed a committee on credentials. On motion the Adjutants of all

Posts present were instructed to give to the A. A. G. a list of their members present and entitled to a vote in this Encampment.

REPORT OF OFFICERS.

Dep. Commander E. P. Brown read his annual report as follows:

Comrades:—The twenty-eighth Annual Encampment, Grand Army of Comrades:—The twenty-eighth Annual Encampment, Grand Army of the Republic, Department of Texas, has passed into history. The affairs the Department and the year have gone by without any material change of the Department and the years that have passed and gone. While, as a in comparison with other years that have passed and gone. While, as a body, we have made no advances, yet no serious calamity has befallen us as a band of the noblest men the nation has even produced. Although we can not have our anticipations realized, we should be thankful for our lives and well-being, and may Heaven continue to bless and smile upon us as she has in days gone by.

In giving an account of my own stewardship to you, I must ask your kind indulgence in overlooking my failures and shortcomings for, truly, I have not been able to come up to a full measure of my expectancy, as many of the Comrades know of the serious trouble that has befallen my wife. She was a victim of a railroad wreck in Kansas last September and has been an invalid ever since, not able to leave her home, and she still continues to be in a most precarious condition.

"The sear and yellow leaf" period in which the Grand Army is now existing, renders it impossible for us to expect anything more than to keep the "lines" dressed with the comparatively few who are remaining, awaiting the call to fall in line and be ready to pass over the river to that beautiful land beyond. I trust that all Comrades will do their duty, one to another, and I regret to see so many of our old soldiers so negligent in their duty. They seem to be content to lie down and sleep, after the government has given them so liberal a pension. I should recommend that all soldiers who can, should unite with some Post and assist us in sustaining our Grand Army in helping other old soldiers, their widows and orphans, to a higher and better living. Comrades, let us hold fast as long as we live and pass no one by who needs our assistance. Do not fail to wear the little bronze button wherever you may go, so that we all will be able to recognize one another, it matters not where we are. May Heaven bless and protect every one of you is my sincere wish.

WOMAN'S RELIEF CORPS.

I am delighted to state that the Woman's Relief Corps still lives and prospers. These good ladies are our helpmates and are doing all they can to advance the great cause of humanity and doing honor in benefitting suffering humanity. They are upholding the principles of our fellow-man and scattering flowers o'er our loved ones, year after year. We shall never forget them and their noble work. We expect some very good reports from these elegant ladies, which will touch our hearts as nothing else can.

FLAG DAY.

May we see that "Old Glory" floats from our house-top so that all who pass by may gain a lesson, by example. Impress upon all children to love

and honor the flag and may the time come to pass when it shall float from every house-top the Star-Spangled Banner. "Oh, long may it wave, o'er the land of the free and the home of the brave."

The following resolutions upon the death of Past Department Commanders were unanimously adopted:

Adam G. Malloy. Born in Tipperary, Ireland, 1828. Came to the United States in 1838, served as fifer in the 4th United States Regular Infantry in the Mexican War. His father was sergeant in the same regiment. In 1861 he was located in Baraboo, Wis. On the first call for volunteers he enlisted in the 6th Wisconsin Infantry and went to the front in the Army of the Potomac as captain of Company A, later was promoted to Lieutenant Colonel and Colonel of the 17th Wisconsin Infantry, an Irish regiment, and assigned to the 17th Army Corps. He was with Sherman on his march to the sea, commanding a brigade. Was discharged at the close of the war as Colonel of the 17th Wisconsin and Brigadier General by Brevet; later was 1st lieutenant in the regular army; Mayor of Jefferson, Texas; Collector of Customs at El Paso; editor of a newspaper in Dallas, Texas; was appointed Chief Immigration officer by President Benjamin Harrison and served in that capacity in Texas and California until his death, which occurred at Escondido, Cal., November 10th, 1911, aged

years. He was elected Department Commander of Texas G. A. R. in 1889 at Fort Worth. He served eight years as Commander of Emmett Crawford Post of El Paso, Texas. He was an ardent worker in the Grand Army, wise in its counsels. The Grand Army mourns his death.

Elmore A. Russell. Military record: Born May 3rd, 1842; died in Paris, Texas, October 20th, 1912, aged 70 years. He was mustered into the service as private in Company F, 85th Pennsylvania Volunteer Infantry; was promoted to Captain October 24th, 1864; severely wounded at Deep Bottom, Va., August 20th, 1864. He was a member of Geo. W. Wright Post No. 26, Paris, Texas. Was elected Department Commander at Dallas 1905. In the death of Past Department Commander Elmore A. Russell, the Grand Army has lost a faithful, loyal and energetic Comrade. He was a gallant soldier, an honorable citizen, beloved by all who knew him. To his bereaved family the department of Texas, G. A. R., extend their most heartfelt sympathy.

Comrade Jno. H. Bolton. Born at Oxford, England, Nov. 3rd, 1840: died in San Antonio, Texas, August 17th, 1912, aged 72 years. His military record: He enlisted August 17th, 1860, in Company I, First United States Infantry as private; served continuously in that regiment all through the Civil War and until May, 1881. He was for many years commissary sergeant and Sergeant Major of that regiment. He participated in many of the fiercest battles of the Civil War, Shiloh, Vicksburg. Champion Hills, Atlanta and Mission Ridge being among them; was frequently commended for gallant conduct in battles.

His civil record: By a long residence in San Antion and his connection with many civic orders he had a wide circle of acquaintances and his friends were as numerous as his acquaintances. He was a Mason of high standing, had held almost every office in that order, including that of Iminent Commander of the Knghts Templar; was a Scottish Rite member of the 32nd degree. By the death of Comrade Jno. H. Bolton, who was elected Department Commander of Texas G. A. R. at Dallas, 1903, this Department sustained an irreparable loss. He was a most energetic Comrade. E. O. C. Ord Post as well as the Department mourns his loss. He will be sadly missed in the councils of the Grand Army. He was a most devoted husband and father. To his family we extend our condolence and sympathy in their great bereavement.

On motion the Encampment adjourned untitl 4 o'clock to partake of the banquet.
