Dallas, Texas, May 7th and 8th, 1915

May 7, 1915— 11 A. M.

Encampment called to order and opened, Robert Mc-Cormick, Department Commander.

Commander announced time had arrived for nomination of officers for ensuing term.

Comrade B. F. Cavins nominated C. S. Broadbent for Commander; seconded by W. F. Conner.

Moved and seconded rules be suspended and the Assistand Adjutant cast the unanimous vote of the Encampment for C. S. Broadbent for Commander for ensuing term. Vote was so cast and Comrade W. F. Conner escorted the comrade to platform. He thanked the Encampment for the honor.

Comrade Sidney Tuttle nominated Comrade M. B. Young for Senior Vice Commander; seconded by A. I. Lockwood of E. O. C. Ord Post; also W. F. Conner of Richard J. Oglesby Post and H. W. Nye of Parmely Post No. 4.

GRAND ARMY OF THE REPUBLIC.

Report of Department Commander.

One year ago you honored me by electing me your Department Commander, and it is now my duty to render to this Encampment an account of my stewardship.

When I assumed the leadership of this great Department I resolved to devote myself unceasingly to the responsibilities placed in my hands, leaving the honors, if any, to take care of themselves.

No Commander of this Department has ever arrived at the parting of the ways, as I do at this time, without some consciousness of how he might have improved more completely the opportunities within his grasp. Yet, we are all out human and realize that human nature can be perfected and developed by experience, which is often acquired too late to be of practical use.

Notwithstanding I have tried honestly and sincerely to uphold the dignity of the exalted position in which you have placed me and to be true to the highest and noblest traditions of the Grand Army of the Republic. The results I leave to you.

The Forty-eighth National Encampment of the Grand Army of the Republic, was held in Detroit, Michigan, August 31st to September 5th, and it is conceded was one of the most brilliant and successful encampments ever held. Detroit is the seventh city in population in the United States, and one of the most beautiful and loyal. The city appropriated \$50,000 for the entertainment of the Grand Army. All the arrangements for the pleasure and comfort of the G. A. R., W. R. C. and the several other affiliated patriotic organizations could not have been improved upon. The Grand Parade on Wednesday, the 2nd, was the crowning event of the occasion. The weather was "just right"; the

line of march was about two miles long, over smooth asphalt streets. Over 15,000 "loyal veterans marched once more to the once familiar and inspiring music of the fife and drum." It is estimated that over 400,000 people viewed this parade. Twenty Texas comrades were in the line. The business of the Encampment was transacted on the 3rd and 4th. Washington, D. C., was selected as the place for holding the 49th Encampment. The following officers were duly elected and installed:

Commander-in-Chief—David J. Palmer, Washington, Iowa.

Senior Vice-Commander-in-Chief—J. B. Griswold, Grand Rapids, Michigan.

Junior Vice-Commander-in-Chief—W. F. Conner, Dallas, Texas, now Senior Vice-Commander-in-Chief, the greatest honor that ever came to a Comrade south of the Mason and Dixon line.

WOMEN'S RELIEF CORPS.

This year we have had for a leader that loyal and patriotic woman, Mrs. Hattie Jack, the wife of a veteran formerly of Parmely Post No. 4, of Fort Worth, Texas, who with her corps of ever ready willing workers has had a watchful eye on all deserving Comrades, their wives and widows; and has always been ready to stretch forth a willing hand to assist a needy Comrade, and may God bless them in their noble work.

MEMORIAL DAY—The heautiful and impressive ceremony performed each year of placing flowers and the flag of our country on the graves of our dead heroes becomes more and more impressive to the rising generation, the sacredness of the day and of its services seems more fully appreciated as the years roll on. Lincoln's Gettysburg address should be read always, as its spirit and sentiment is most likely to inspire the young.

GALVESTON FUND—There was given to me by my predecessor \$197.08, all of which still remains in my hands to be handed to my successor.

Now that the hour has arrived to again take my place in the ranks, I assure you that I do so with a heart filled with love and good will, and overflowing with gratitude for the cordial support which I have had from the Comrades of this Department. I feel that I have been honored as but few men have and the memories of this year will be a precious bequest to my descendants. Department Commanders of these days are fortunate in having the best thought and advice of a long line of illustrious predecessors to serve as a guiding star leading ever upward; to these splendid men, my former Comrades, I am grateful that they so blazed the way that but few difficulties were left to me, and now I wish to express my sincere thanks for the loyal support I have received from each and every one of you.

May we all so live that when the summons comes for us to fold our tent and go to meet the Great Commander, we shall hear Him say, "Well done good and faithful servant, enter into the joy of thy Lord.

Report received and adopted.

Robert McCormick, Commander Department of Texas, G. A. R., and Comrades:

The record of another year is closed. It has been largely one of hope but there has been some fruition. My report is almost wholly local, for reasons hereafter referred to, and is mainly a record of effort in the jurisdiction of Ord. Post and its faithful auxiliaries, the Women's Relief Corps, and the Ladies' Circle of the G. A. R.

May 24th, Memorial Sunday, we held services at the Evangelical Church in San Antonio, where Rev. Garfield Johnson preached a strong patriotic sermon to a crowded house. Fine vocal and instrumental music, church decorated with National flags and everybody inspired and proud that they were Americans. I sent programs of Memorial Day to be read in the principal churches of the City, and also had the same published in our papers. Joseph Emerson Smith, editor of the Express, delivered an unusually eloquent address at the National Cemetery on Memorial Day, to about two thousand people. A battery fired a salute and a military band discoursed music. Two thousand graves were decorated, and the usual Memorial Day program was carried out. In the afternoon services were held

on the river bank, flowers were cast on the water, and Rev. Garfield Johnson gave an earnest address on the text, "Ye are the sait of the earth." In the evening at Trinity Methodist Church a program of song and an address by the Department Patriotic Instructor.

· · I had notice of Flag Day published in our papers and they also gave large space to the history of our flag.

I attended the Elks' annual celebration of Flag Day at their hall, where Attorney Harry Hertzberg and others made patirotic addresses, interspersed with National songs. The Elks, I believe, is the only civil organization in our country that is obligated by their laws to keep a National patriotic day, and they have chosen Flag Day.

June 16th, the Spanish War Veterans and their auxiliaries, celebrated Flag Day at their hall with a good program and talks by Comrades.

June 17th the General 4th of July Committee met and thereafter met every Wednesday afternoon. This committee is a standing one from year to year, made up of Spanish War Veterans and auxiliary, Daughters of Republic of Texas, Redmen and Degree of Pocohontas, Degree of Honor, United Confederate Venterans and Daughters of Confederacy, Grand Army of the Republic, Women's Relief Corps, Ladies Circle of G. A. R., Woodmen, etc.

A large military and civic parade took place in the morning and the Declaration of Independence was read, with addresses and music, and games in the afternoon.

For some month I had been considering the feasibility of the enactment of a public school state flag law, and to this end procured the school laws of several states having a flag law. Comrade Lockwood copied these laws and we took up this subject with our Senator, Hon. Carlos Bee, who heartily approved the subject. He wrote me from Austin February 4th, "Your letter with enclosures received. I shall, at the first opportunity, prepare a bill according to the data sent me." After the close of the session he told

us the press of legislative work was so great that he had been unable to reach this proposed bill but would take it up at the next session. This, I consider, a most important piece of work, and I hope will be followed to a successful conclusion, as also a law to prevent the desecration of the flag. Think what it would mean to our ten thousand public schools, and our million pupils, think what it would mean to our immigrants and to our moral and material interests of our state. A flag in every school house would carry with ita course of patriotic teaching, and as State Superintendent Doughty says: "There is not enough of it now taught in our schools." Flag raising and flag waving are good as far as they go, but a patriotic text book should go with them. It all loyal hearts, and doubtless neighboring would thrill states would quickly fall in line. All of you can assist in this by calling the attention of your Senators and Representatives to it.

Mr. J. S. Lockwood, a retired banker of our city, placed in my hands five beautiful flags, to be given to schools in Bexar county outside of the city. After consulting County Superintendent Stewart I placed them in good schools employing two teachers each, and averaging about eighty pupils, thus reaching ten teachers, four hundred pupils and five we'l settled districts. The complimentary letters that flew back and forth on account of this splendid gift are too vlouminous to incorporate in this report.

February 19th I presented for the Women's Relief Corps a flag to our Garden Street School, Miss Baskin, Principal, 17 teachers, 540 pupils.

Sunshine and ciouds alternate. We have had the brightness, now we must have a little gloom. A peculiar condition exists attributable to our rules that has caused me to receive no Post Patriotic Instructors' reports since our last Encampment. Assistant Adjutant General Dunlap wrote me, in answer to my letter, that he had mailed blanks to Post Patriotic Instructors in June, and he states that these

reports are due not later than June 15th. The reports for the present year will be due after our State Encampment, and the only reports that are due from which you make your report are the ones for June 15th, 1914."

According to this, our rule ought to be changed or our Encampment be held after June 15. I included in my report last year all the Post reports to that date received. Now, if the Post reports for the year June 15, 1914, to June 1915, come in between now and June 15th they cannot be reported to you until our 1916 Encampment, which will be rather stale news and on a par with some of the United States Census reports. I deeply regret for you and for myself that I am in ignorance of the patriotic work in the Department generally since our last Encampment. I have no copy of the rules and by-laws of the Department, nor of the method of altering or amending them, but we can all see the lamentable defect and how the work of the Department Instructor is curtaild, and that this condition calls for an immediate remedy. Doubtless there has been effective work done and the workers ought to be given credit for it in our Encampment reports before they die. Each Post wants to know what the other Posts have done, what they intend to do, and how they will go about it. Our annual Encampment is the clearing house for ideas, methods, advice and suggestions as well as of reports on what has a ready been done.

The time is ripe for work. All times are ripe for good work. "A time like this demands men and women, great hearts, strong minds, true faith and willing hands." Quoting Ruskin, "I care not where the work is, the man or woman who does work worth while is the man or woman who lives, breathes and sleeps that work; with whom it is ever present in his or her soul, whose ambition is to do it well and feel rewarded by the thought of having done it well."

The same thoughts gave energy to the efforts of good men and women before the birth of Mohamet, before the dawn of Christianity, and howsoever dark the future may

sometimes be, and how at times reason seems to be dethroned, the press of unjust wars and dire cruelty push peace and kindness behind time's curtain, yet do we feel and know that ultimately right and justice, love and benevolence will be enthroned and will rule mankind to the uttermost ends of the earth. Modern teaching dwells too strongly on the vices of past ages and not enough on their virtues. No stronger code of morals obtains today than was advocated hundreds, even thousands, of years ago. Hear the word of Alfred the Great of England: "God has made all men equally noble in their original nature. True nobility is in the mind, not in the flesh. I wished to live honorably whilst I lived, and after my life, to leave to the men who were after me my memory in good works." Like sentiments are these by a present day moralist at the dedication of a monument at the grave of our own Sam Houston: "It is of little moment whether one dies today or tomorrow, it is all important that while living he shall, for things worth living for, leave the world better for his having lived in it, and dying live again in the lives of those who have been inspired by his words and example."

Your committee appointed to frame resolutions on the death of our three Post Department Commanders, since our last meeting, beg to offer the following:

Comrade T. M. Wright died Aug. 25th, 1914, at his home in Denison where he was a highly respected citizen. He was a soldier of high record in the 2nd Illinois Cavalry, and served his country with great credit to himself and the flag. His record as a Grand Army Comrade is second to none and he was held in such great esteem by the Comrades of this Department that he was made our Commander in 1908, which position he filled to the uplifting of our Department.

Comrade P. B. Hunt died April 5th, 1915, at his home at Dallas, Texas, where he was one of the most prominent and respected citizens, where just prior to his death and for some years he held a position of great trust and responsibility under the Government of the United States. He was a galant soldier during the war and was Lieutenant Colonel of the 4th Kentucky Infantry. He was an exemplary Comrade of the Grand Army and in 1901 he was elected as Commander of our Department, and won the love and esteem of his Comrades by his many acts of F., C. & L.

Comrade C. R. Hubbard died at his home in Lampasas, April 30, 1915, where he was a prominent and highly respected citizen. He was a galant soldier of the 6th Wisconsin and rendered splendid service to his country under Old Glory; and in 1909 he was elected Commander of this Department because of his able, devoted and splendid service rendered at all times and because of the F., C. & L. esteem in which he was held by all his Comrades.

In the death of these Comrades every Comrade of our Department has lost three of our best supports—and each city where they lived they have lost their most highly respected citizens and worthy patriots. These gallant defenders of the Union in the days of its peril have taken up

their line of march to "Fame's eternal camping ground," and if their spirits hover about us today they must be filled with gladness, and could they but speak they would say God bless your work of F., C. & S., and bid us join them when our work is done.

We are consoled by the fact that these three most honored Comrades lived to a good age and lived to enjoy the fruits of their labors and to see this people reunited and our country made glorious by a heroism and a patriotism—in which they each had a part—that will live in the hearts of the American people down to the remotest generation.

We'll hide their loving memory in our hearts; We'll follow in the pathway that they trod; We'll make each day another step upon The stairway leading up to them and God.

Resolved that the sympathy and condolence of this Encampment be extended to the families of each of these, our Comrades, and we mourn with them the loss of three of our grandest Comrades, and let us so conduct our lives that we may join them when we are called upon to cross the river and join them on the other side.
