



JOURNAL

The 31st Annual Encampment G. A. R., Dept. of Texas convened in I. O. O. F. Hall on Crockett St., April 28th, 1916, at 9 o'clock A. M.

The Post opened in due form by Post Commander Robbins. And the gavel was turned over to Department Commander, C. S. Brodbent.

Rev. Dr. Leonard opened the Encampment with prayer.

Mayor Brown, of San Antonio then made the welcoming address to the representatives of the Grand Army of the Republic present, which met with hearty applause.

The Department Commander responded in a touching short address, reminding the comrades that we are now in the last days of this great organization which stands in a class by itself.

Nothing of its character and magnitude ever having preceded it, and its duration of necessity limited to the longevity of the Veterans of the Civil War.

Colonel Waltz, Commander of Ft. Sam Houston gave the comrades a very stirring and patriotic address, which met an appreciative response from the audience; paying a high tribute to the veterans and giving assurance that as long as he was in command the Grand Army should always have due recognition.

The Military Band from Ft. Sam Houston rendering splendid music the while.

General Clem, a retired United States Army officer, then made a short address.

A Committee of General David S. Stanley Circle; Ladies of the Grand Army of the Republic, viz: President, Mrs. Jennie Green; Secretary, Mrs. Lula Crosby; Treasurer, Mrs. Louise T. Ewing; Patriotic Instructor, Mrs. Ida Martin, were ushered into the Hall to give greeting. The President said; "Comrades: Veterans, and Ladies of the W. R.C.! I suppose you are wondering who we are and what we are doing here: This lady is my Secretary, Mrs. Lula Crosby. The next is my Treasurer, Mrs. Louise T. Ewing. The next is Mrs. Ida Martin our Patriotic Instructor; all of General David Stanley Circle No. 3 Ladies of the Grand Army of the Republic and I am its President, Mrs. Jennie A. Green, at your service.

A telegram from Col. Bingham, U. S. A. in remembrance of Past Department Commander, Sidney Tuttle was received.

Recess.

Convened in Executive Session.

Motion by Comrade Conner that all present members of the Department be made members of the Encampment with voting privilege, carried 37 to 15.

Department Commander Brodbent then delivered his address to the Encampment, as follows:

ADDRESS OF THE DEPARTMENT COMMANDER

COMRADES.—We welome you to the Thirty-First Annual Eucampment of the Grand Army of the Republic, Department of Texas.

These yearly reunions are pleasant and profitable and grow more precious as time thins our ranks and our physical strength wanes. Like all my late predecessors I deplore the fact that results for the year have not been satisfactory. From the columns of The National Tribune and other sources I have learned of comrades locating in Texas from other Departments and have given them notice, not only by personal letters, but in Orders and through the press that all eligibles outside of Bexar County, could join us by the payment of one dollar per year. The response has been neglible. Few Comrades are now under 70 years of age, which they may deem sufficient cause for declining to take an active part in affairs outside their domestic circle. The past however, is secure and in our National annals the history of the Grand Army of the Republic has and can have no duplicate.

The Pension Department informs me that there are about 3000 pensioners in this Department. How many are veterans of the CivilWar can be learned only by an examination of the rolls. A list of such with their addresses can be obtained from the Pension office. Whether the results would warrant the expense is questionable. My own experience in trying to win members would compel a negative answer.

FLAG LEGISLATION.

Measures have been taken with good promise of success to have a School Flag law and an anti-desecration Flag law enacted by our next legislature. Doubtless my successor and all other Comrades and our Auxiliaries will help push this worthy object to an early triumph. No greater patriotic work has been given us to do. Let us do it with a will.

OFFICERS' REPORTS.

Full, and I opine, satisfactory reports will be rendered you by the several Department officers, to which I invite your careful attention. We have been favored with the services of a conscientious, intelligent Staff. Asst. Adjt. and Q. M. Gen. Ewing has been indefatigable in the discharge of his duties, and like acknowledgment must be accorded Dept. Patriotic Instructor Cowles. Much of their work has come under my personal noicet and I am proud to testify to its merit.

WOMAN'S RELIEF CORPS.

This beneficent auxiliary organization under the strong leadership of President Verna S. Irvin, has lived up to the high standard of the past. It challenges our admiration and has ever been ready with good works and noble deeds to minister to the comfort and needs of the veterans, to care for the widows and orphans, to decorate the graves of the noble dead, and to keep alive their virtues. No call for aid has been unheeded and no hand withheld from tender ministry.

GEN. DAVID S. STANLEY CIRCLE LADIES OF THE G.A.R.

Like its sister association, it has been fruitful in the field of mercy, care and loving kindness. In visiting the sick, comforting the afflicted, inspiring hope in the depressed, it has exemplified the highest type of American womanhood and has made its name beloved in the home of distress and in the banquet halls as well. Both these associations have shown commendable zeal in patriotic work. They have presented flags, visited schools, attended meetings, and have neglected no opportunity to teach lessons of patriotism, especially to the children. Yea, they have created opportunities.

Sons of Veterans.

A tentative effort was made by Ord Post to organize a Sons of Veterans Post, but it was pronounced impraticable. A canvas

MEMORIAL DAY.

There is no dimunition of interest in the sacred observance of Memorial Day. The remembrance of the departed Comrades is kept green in the hearts of all by the strewing of fragrant flowers on their graves and the eloquent recital of their deathless deeds. From end to end of our country Memorial Day proclaims that the saviors of our Union are embalmed in the heart of the Nation and that the Nation is their glorious, imperishable monument, and thus shall Memorial Day be kept from generation to generation as long as the Star Spangled Banner kisses the breezes of heaven.

DEFUNCT POSTS.

It will be seen from the Asst. Adjt. General's report, and greatly to my sorrow, that several Posts have surrendered their Charters. This was not willingly done but of necessity, through death reducing membership below requirement of Regulations. This result is inevitable, -is beyond human control, and has been forseen for years, yet like the long expected death of a friend, when the stroke does fall it gives one a painful shock.

THE GALVESTON FUND.

I received from my predecessor \$197.08, the amount of the Galveston Fund. In August a disastrous storm visited Galveston, Houston and vicinity, causing grevious loss and privation. A call for aid came from Comrades and on Sept. 16th, by authority of the Council of Administration, I remitted to Comrade Max Hart, Commander McClellan Post No. 9, at Houston, the amount of \$197.08 plus \$2.13 interest, a total of \$199.21 for distribution A list of the names of recipients and the to needy Comrades. several amounts paid was sent by Commander Hart to the Adjt. General of the Department. Thus closes the beneficent record of the Galveston Fund.

So much has been told of the 49th National Encampment at Washington that further expression is unnecessary, only to repeat it was a magnificent outpouring of patriotic sentiment in a magnificent setting, worthy of our magnificent Nation, and marks a glorious page in our history.

In handing the gavel of authority to my successor I can assure you my heart has been in the work, and words fail to express my gratitude for the honors conferred on me and mine. I sincerely thank all officers, comrades and auxiliaries for their unstinted aid and loyalty. In the hope and trust that the labor of our generation has proven to be, and will continue to be, a rich blessing to our race, I am

REPORT OF THE DEPT. PATRIOTIC INSTRUCTOR.

C. S. Brodbent,

Com. Dept. of Texas, G. A. R.

In making my annual report I can add but little to what has transpired in the vicinity of E. O. C. Ord Post. I sent blank reports to all the Patriotic Instructors of the different Posts in this Department. I have received reports from but few of them. It is very evident a great many of our Posts are so reduced in membership as not to be able to hold meetings at all. Others only occasionally and that at the home of some of the comrades.

Post No. 2, of Galveston reports having placed a flag at one school at the Commander's own expense, the Post having no funds for that purpose.

Post No. 9, at Houston reports the placing of three flags in as many schools, and that nearly all schools are now supplied with flags.

They report a decided increase in patriotism during the past year owing to their patriotic Mayor taking a very active part in the work.

Post No. 54, of Corpus Christi reports the presenting of a

flag to one school by the Women's Relief Corps.

I am glad to say E. O. C. Ord Post has still sufficient membership to keep in good working condition and have done a little work in the cause of patriotism.

The Women's Relief Corps, the Ladies of the Grand Army and the Post have presented flags to four different schools.

On Sept. 13th under the generosity of Officials of Fort Sam Houston we were furnished a large motor truck which, filled with ladies and comrades. we proceeded to Pleasanton, Atascosa Connty, and presented a flag to the High School of that town. This school has 8 teachers and 270 pupils.

Oct. 18, we presented a flag to the High School of San Antonio which has 35 teachers and 1300 pupils.

Jan. 26, we presented a flag to Robt. E. Green Memorial School which has 5 teachers and 130 pupils.

Also presented flag to Crockett School for having the best flag drill.

In all schools where we have placed flags the teachers and pupils have shown great interest in the occasions by flag drills. patriotic songs, etc.

I wish to state we are working now for a law to prohibit the desecration in any manner of our flag, and we have the assurance from our State Senator from this district that he will endeavor to have such a law enacted at the next session of our Legislature.

On last Memorial Sunday accompanied by our lady auxilaries we attended the Trinity M. E. church and listened to a porwerful sermon by Bishop W. P. Threlkeld, of New Orleans.

On Memorial Day we assembled at the National Cemetery and held the usual excercises. Fort Sam Houston furnished us a band, a battery of artillery and a firing squad.

A committee of the ladies decorated the 2,000 graves of our departed comrades.

Flag Day, June 14, I not only requested the city papers to ask our people to display flags, but called upon Gen'l Manager Tuttle of the Traction Co., and through his generosity each conductor and motorman of the line wore a miniature flag on their coats.

July 4th the different patriotic societies held a grand parade, after which we repaired to San Pedro Park and held exercises suitable of the day.

Nov. 19 the Liberty Bell was on exhibition for a few hours in San Antonio. All schools closed and thousands witnessed the old relic.

Lincoln's birthday was celebrated by the Post and ladies, in the ball room of the Gunter Hotel and attracted a large number of people.

Washington's birthday was well observed by our whole people. All public schools had excercises in honor of the event. Flags were displayed from public and private buildings and business generally suspended.

Ord Post and the Women's Relief Corps held exercises in the Post hall.

In conclusion I wish to say the Women's Relief Corps and the Ladies of the G.A.R. have ever been ready to lend us aid in all our patriotic excercises and in many cases have taken the lead and carried them through to successful issues, for which we owe them our grateful appreciation.

RESOLUTION ON PREPAREDNESS

Young, President of an Association for Equal National Service; and in view of the staggering facts as they are daily revealed to us through the public press, of fifteen civilized Nations in deadly conflict, hurling the best of their young manhood to death each day by the thousands, and for which crime no better excuse has been invented than self-preservation, which might well serve for the invaded countries who are compelled to fight for home and country; but for the invader it stands forth as a palpable subterfuge. Therefore, be it

Resolved. That it is the sense of this Encampment of the Grand Army of the Ropublic, Department of Texas, here assembled, that Congress should at once adopt a comprehensive and

energetic system of adequate preparedness, both of Army and Navy, to the end that when the fateful hour strikes, we may be found ready eo do valiant and successful battle, as always for the preservation of this Government of the people, for the people and by the people, that it may not perish from the earth.

On motion of Comrade Ketchum, and seconded by Comrade Allgaier that it be adopted, was unanimously carried.

A committee consisting of Comrades Hart and Robbins was appointed to notify the Womans Relief Corps that the Encampment was ready to receive their communication.

The Asst. Adj. Gen'l then read a letter from T. O. Proctor, Adjutant of Geo. W. Wright Post No. 26, at Paris, stating they had lost everything by fire.

On motion of Comrade Conner that an amount be contributed to help the Comrades of Paris to start again, was carried.

The amount so raised being \$15.50, which was turned over to the Adjt and Quartermaster General for delivery.

On motion the Encampment gave its unanimous endorsement to the following bill now pending in the U.S. Senate:

A BILL

Authorizing the promotion of an officer on the retired list of the Army who served in the Civil War.

Be it enacted by the Senate and House of Representatives of the United States of America in Congress assembled,

That the President be, and he is hereby, authorized to appoint and place him on the retired list of the Armywith the rank of major general any officer who served not less than one year in the Regular or Volunteer forces of the United States during the Civil War prior to April ninth, eighteen hundred and sixty-five, and who was honorably discharged therefrom, who shall since

have served not less than forty years as a commissioned officer of the Regular Army, and who was the last Civil War Veteran of the Regular Army, and who was the last Civil War Veteran on the active list for over two years before retirement and had on the active list for over two years before retirement and had ranked every general officer on the active list in length of service when he retired.

Comrade W. F. Conner then offered the following resolution which was seconded by Comrades Ewing and Nye. Carried.

Whereas: In the call of President Lincoln for volunteers to defend the Union, it was promised that all volunteers should receive the same treatment as the officers and soldiers of the regular Army; and,

Whereas: Placing full credence in said promises, the young manhood of the nation rallied to its defense; and,


Whereas: After a lapse of more than fifty years, those promises in regard to the men who by capacity, merit and bravery earned promotion but have not received the treatment promised and abundantly earned;

Therefore, be it Resolved: That the Department of Texas Grand Army of the Republic, in annual encampment assembled, respectfully ask the Congress of the United States to recognize the just claim of the officers who led and cared for us during the dark days of the Civil War, by placing the remaining survivors on the Retired List with all the benefits accruing to officers of the Regular Army of like rank; and,

Be it further Resolved: That a copy of this resolution, duly authenticated, be forwarded by the Adjutant General at Cincinnati, Ohio, to all the members of Congress and Senators from the State of Texas, and to the Assistant Adjutants General of the various Departments of the Grand Army of the Republic, with the request that it may receive their favorable consideration and support.

SIDNEY TUTTLE was born in Bolton, on Lake George, Warren

Gounty, New York, September 3d, 1834.

At the age of eighteen he engaged in the mercantile business in Ches-

tertown and Albany, New York.

At the outbreak of the War of the Rebellion he assisted in organizing the 15th New York Gavalry, and was Commissioned as First Lieut. and Adjutant of that regiment. He served under Sheridan and Guster in the Shenandoah Valley, until the close of the war, with valor and

He came to Texas in 1872 and at once became connected with the railroad interests, serving with ability in many official capacities for many years with the International & Great Northern and San Antonio & Aransas Pass Railroads, living the greater part of the time in San Antonio, where he was well known socially and in a business capacity.

He is survived by his daughter, Mrs. Nellie Fuchs, of San Antonio, and a son, Sidney W. Tuttle of NewYork City, and sisters, Miss Roxie G. Tuttle, Mrs. George Conkhite, of Lake George, New York, and Mrs. William K. Bixby, of St. Louis, Mo., and a brother, Jay Tuttle, of Lake George, New York.

As a Gomrade of the Grand Army, he has been a tower of strength in his Post, E. O. G. Ord No. 3, for many years, and has filled many

offices with honor to himself and credit to the Post.

In 1913 he was elected Department Commander and filled that position ably and well to the satisfaction of all his Comrades.

Comrades of the Grand Army of the Republic, and of the Womans Relief Corps, and friends. The Womens Relief Corps of the Department of Texas, feel highly honored, being privileged to present this our country's Flag to Trinity Methodist Church, we feel that in this glad act we in part liquidate some of our many obligations to that Church, which has ever stood by our efforts to keep this banner aloft as our National emblem. In this City of many Flags,—Mexican Flag, Texas Flag, and Confederate Flag. If we do not keep the record straight, there is liable to be confusion.

The Mexican Flag stood for barbarous Mexico. The Texas Flag stood for struggling freedom. The Confederate Flag stood for human slavery.

While this starry banner stands for Freedom, Justice and Equal Rights.

Always and Ever. Long may it Wave, __(applause).

The Churches while receiving their inspiration from the common source, the written word of God have displayed such amazing ingenuity in its interpretation, as to be almost be-wildering. But we have ever found Trinity and its Pastors marching to the music of the Union, Peace on Earth and Good Will to Men. With the prayer of the Patriot not only in their hearts but exemplified in their daily life, towit:

O Thou whose equal purpose runs In drops of rain or streams or suns, And with a soft compulsion rolls, The green earth on her snowy polls, O Thou who keepest in thy ken
The times of flowers the dooms of men,
Stretch out Thy mighty wing above
Be tender to the land we love.

When in the dark eternal tower,
The Star-clock strikes the trial hour,
When for her no more avail,
Her sea-blue shield and mountain mail,
But sweeping wide from Gulf to Lakes,
The battle on her forehead breaks,
Throw Thy victorious wing above,
Be Lightning for the Land we Love.

REPLY OF REV. H. C. LEONARD.

"Ladies of the W. R. C. and Comrades of the G. A. R. in behalf of the Trinity Methodist Episcopal Church I accept this flag with thanks. Such a gift to a church is most befitting. The church could not exist without the protection of the flag nor could the nation stand without the foundations laid in the church. The flag of our Country and the banner of the Cross most fittingly drape together. The one has stood for civil liberty—the right to life, liberty and the pursuits of happiness; the other has stood for the freedom of man himself from ignorance, superstition and moral slavery. Both are drenched with red blood of sacrifice. The truth of the Cross has made the Flag. Wherever they have gone dull minds have opened and slavery's chains have fallen."

"As a nation our mission has broadened. When this flag was first unfurled we were in a struggle to free ourselves from foreign domination; after the course of time when realizing that a nation dedicated to freedom could not exist half slave and half free you men threw yourselves into the battle front to rid our land of human slavery; and in these last days we have heard the cry of nations far removed by alien clime and tongue and have brought to them the truth held in the folds of this flag. A broader mission still rests with the church and the nation—to free ourselves of selfishness and greed."

"In the beauty of the lilies Christ was born across the sea With a glory in his bosom that transfigures you and me. As he died to make men holy let us die to make men free."

"How full of meaning are these colors! Here we have the red of sacrifice gathered from the battle fields of Freedom's slain—the blood of those who gave the last "full measure of devotion." In this red the blood of heroes speak calling men of today to consecrate their lives for their country's high advancement. In this white we see the purity to which we are striveing—the hopes of those who dreamed and wrought. Truth is symbolized in the blue. The truth of civil liberty are here, the truth that began to form at Runnymeade and for which men fought in the days of Cromwell and Washington and Lincoln. In this truth are set the stars of the several states and speaking to them always and saying—"in the field of truth are you resting and by the truth are you held as one and only in this blue sky of truth shall you abide forever."

"The protection of this flag reaches around the world and it is time that those who are the spokesmen of this country should be saying to the nations of the earth that all who bear this name and sign are beneath its protection in every land and on every sea. We have forgotten the richness of our heritage when we fail to support the truth of this sacred banner with adequate armies and navies."

Again I wish to thank you on behalf of the children who will see this flag in the House of God. Into their minds must be wrought a sterling love for our country. Your organizations have done much in creating an atmosphere of patriotism but there is yet work to be done. I thank you.
