

Unofficial Proceedings 32nd Annual Encampment, Department of Texas, G. A. R.

Fort Worth, Tex., May 15, 1917.

The Ladies of the Parmley Woman's Relief Corps instituted a reception at the Metropolitan hotel at 8 p. m., in honor of the visiting ladies and comrades that was quite entertaining and most heartily enjoyed by all who participated therein.

Opening of the 32nd Annual Encampment, Department of Texas, Grand Army of the Republic, at W. O. W. Hall 10 A. M., May 16th, 1917.

Song, "America," audience and choir, led by Professor Thomas Holt Hubbard.

Prayer, by Rev. H. H. Twyford.

Address of welcome, by Judge Powell, representing the Mayor of Fort Worth, which was most patriotic; embodying a hearty welcome to the city of Fort Worth, to its guests, the Grand Army of the Republic, Woman's Relief Corps and Ladies of the G. A. R.

Responded to by Comrade Brodbent, of San Antonio.

After these addresses, the choir rendered the song, "Hail To Our Star-Gemmed Flag."

While this was being sung there appeared on the floor Comrade Ell Torrence, Past Commander-in-Chief, who while in attendance on the General Assembly of the Presbyterian Church, U. S. A., at Dallas, heard of our meeting, and came over to greet us and a right hearty greeting was his, after which was sung by choir and audience, "The Star Spangled Banner," Comrade Conner, escorting the flag to the front. The noon hour having arrived, "Fall Out for Grub" was sounded, and all hands adjourned to the dining hall, where, after grace, a bountiful lunch was served by the Fort Worth W. R. C. to its guests who showed their appreciation by leaving the cuttlery and other articles of service.

Adjourned to 2 p. m., when will be taken up the regular order of business of the 32nd Encampment.

Encampment called to order by Assistant Adjutant General; Comrade G. Helbing appointed officer of the day, who, after taking up the countersign, announced all present members.

On the gavel being turned over to Commander Cahoon by Comrade Nye, he immediately assumed command and delivered his address:

Comrades of the Department of Texas, Grand Army of the Republic:

I am, as we all are, most thankful to The Grand Commander of all for this privilege of being permitted to participate in the Thirty-second Encampment of the Department of Texas, when so many of our comrades have answered their last Roll Call. Again, I must thank you for the honor conferred upon me at our Thirty-first Encampment, asking your forgiveness for my inability to visit you all, because of ill health to myself and others in my family. I was able to visit only three posts in the Department.

As our country has at last been forced to take a hand in the great struggle now absorbing all of Europe, it behooves every American with any love of country and pride in his nationalism, to come out openly and express it to others on all occasions. And there is no better way than in the display of our National Emblem: place the American flag over your home every morning at sunrise, take it down at sunset. Let this be the daily duty of every Grand Army man, his sons and his daughters, if they head families of their own; wear the flag on the lapel of your coat, let our women show it on their dresses. Encourage the children to carry a minature flag to and from school, that the children of others may love and admire it. THIS IS THE DAY THAT THE AMERICAN FLAG COMES INTO ITS OWN; therefore it behooves every Grand Army man, every American man, woman and child to uphold it, in standing behind the President of the United States with our good will, our fortunes, and, if necessary, our lives.

Congress has given the country a proper law under which the President may form our army in the future; thus doing away with the bounty and the "bounty jumper," the bane of the recruiting service and the curse of the army. Now every citizen will be called upon to do his own share of service for the country that has afforded him a home and the right to the peaceful pursuits of happiness.

During these stirring times of awakening American patriotism, let the members of the Grand Army be very active, assisting in any way each can, the government and its agents, in putting together and perfecting our New Army. And, incidentally, gathering into our posts all Old Soldiers of 61-65 who are entitled to membership.

Since our last meeting, the Grim Reaper has not neglected our Order, for he has reduced our membership very materially, and added their names to our Roll of Honor. Among these most prominently we find the names of Comrades H. A. Johnson, Post Commander, McPherson Post 1, of Sherman; W. O. Kretsinger, of Nat Lyon Post 4, of Denison; L. L. Whitaker, of E. O. C. Ord Post 3, of San Antonio, the last two named being Past Department Commanders. With these, passed H. C. Adler, Post Commander, Garfield Post 83, of Victoria—these last three prominent in our councils passed since the first of this New Year.

These are sad reminders of Memorial Day, and its loving duties. There is nothing in our Order that brings our souls nearer together than our Memorial Day and its beautiful services. On the Sabbath preceding and on this day let each Post act, an object lesson to rising generations and to the future Republics of Europe; so that Our Memorial Day shall become the International Sacred Day on which all Nations shall honor their noble dead.

June 14th has been named Flag-Day. Let it be a Red Letter Day in your calendar—and this year do it full justice.

Let me here thank those members of our Department who with me attended the National Encampment at Kansas City, adding some twenty units to the marching line. And as the coming National is to occur in August of this year in the city of Boston, let every one who can, make an effort, strain his purse string, and attend; for Boston never extends its hospitality and welcome by halves. Again thanking you, my comrades, for the highest honor in the

gift of the Department, and all my official family, for making a success of my poor administration, promising that while life lasts I shall endeavor to continue an active Grand Army Comrade in the ranks of our beloved Order.

The same was enthusiastically received by the Encampment, and ordered spread upon the minutes as a part of the proceedings of the Encampment.

Mrs. A. M. Wingrove asked the assistance of this Department, at the Fifty-first National Encampment, by its endorsement for W. R. C. National honors, of Mrs. Lizzie Durham as Junior Vice President of the National Woman's Relief Corps.

A motion duly seconded was adopted, that the request be complied with.

Comrade Conner, in behalf of the Encampment, thanked the ladies for their greetings and presence.

The Encampment rose and stood while the ladies retired from the hall.

Chaplain's Report.

The commander appointed a committee consisting of Conner, Brodbent and C. P. Brown to visit the Woman's Relief Corps, and return greetings.

On account of the death of the medical director, no report was rendered.

Comrade Lockwood presented the following:

"Taps have sounded.

Lights are out.

The soldier is at rest."

Death, the Grim Destroyer, has again invaded our ranks, and stricken from our rolls a worthy comrade; he has gone to his Eternal Home, and has joined that Grand Army above, whose serried columns are ever silently, invisibly, but irresistibly marching on.

No more will we see his portly form, or hear his resonant voice in our councils or at our social meetings; the genial smile has faded, the sparkling eyes are closed and the ready tongue is stilled forever, the seal of Death is upon them.

Comrade Whitaker was born in Morgan County, Ohio, on March 18, 1835, and he died in San Antonio, Texas, on April 16, 1917.

In his youthful days he moved to the state of Illinois, and soon became quite prominent in the politics of that state, and was elected a delegate to the Charleston Democratic Convention, held in 1860.

In 1862 he enlisted in Company F of the 126th Illinois Infantry, and served his full term of three years, being discharged in 1865 by reason of expiration of service.

Coming to Texas in 1872, he engaged in the practice of his profession of medicine, which he followed for thirty years or more.

He was mustered into Ord Post, Grand Army of the Republic, on March 23, 1900, and for a number of years was an active and valuable member of the Grand Army of the Republic.

His comrades honored him by electing him Department Commander in 1907, he having previously been elected Post Commander by his comrades of Ord Post.

At the National Encampment, held at Los Angeles in 1913, he was further honored by being elected Surgeon General of the Grand Army of the Republic.

Full of years and honors, he has answered the Summons, which sooner or later will come to us all.

Therefore, Be It Resolved, That in the death of Comrade Whitaker the Grand Army of the Republic has lost a valued member, our state and country a loyal citizen, and his family an indulgent and loving parent.

And further, That these lines be spread upon the minutes of the 32nd Department Encampment, and a copy furnished the family of our departed comrade.

On motion of Comrade Nye, seconded by Comrade Conner, Comrades Ketchum and Dunlap were constituted a committee to properly express the thanks of this Encampment to all who have so kindly contributed to our entertainment during our sojourn within the gates of the fair city of Fort Worth.

The committee appointed by the Commander to audit the report of the Assistant Quartermaster General submitted the following:

Report of Patriotic Instructor.

Fort Worth, Tex., May 16, 1917.

Comrade C. A. Cahoon, Commander Department of Texas, Grand Army of the Republic.

I was not informed of my appointment as Patriotic Instructor of this department until after the 15th of June, 1916, the date for Past Patriotic Instructor to make their reports, and received only the report of Comrade W. F. Conner of Richard J. Oglesby Post No. 6. This report was received about July the 4th, and is as follows:

Many school buildings supplied with American flags by The Woman's Relief Corps."

Observance of Special Patriotic days by the Grand Army of the Republic and Woman's Relief Corps: Washington's and Lincoln's Birthdays, Memorial Sunday and Flag Days.

I have unofficial reports from all posts and our auxilary, the Woman's Relief Corps, that the duties required by rules and regulations in regard to Memorial Sunday, Memorial and Flag Days have been faithfully performed, and that many flags have been presented to schools.

It is with much regret that I am unable to give further information concerning patriotic duties performed by the posts and corps of this Department, and believe this is the result of confusion or the inappropriate date for post patriotic instructors to make reports to the Department.

Rules and Regulations, Art. II, Sec. 7, says: "That the Patriotic Instructor of each post shall through the Post Commander make a report upon forms obtained from the Assistant Adjutant General of the Department within thirty

days after receiving notice from Department Commander and forward same direct to Patriotic Instructor of the Department, who shall in turn make a report to the National Patriotic Instructor thirty days prior to the meeting of the National Encampment."

Now the blank forms above referred to have printed instructions, saying: "this report must be made not later than June 15th of the current year."

If this date is to be strictly observed no Department Patriotic Instructor will have such information as to enable him to make an intelligent and comprehensive report, either to the Department or the National Encampment. Therefore, I believe if we are to keep a record of our patriotic work, a change should be made as to time of making reports or a later date (some time subsequent to June 15th) named for holding the State Encampment. Comrade C. S. Broadbent, in his last report as Department Patriotic Instructor, made this same suggestion, but no action was taken thereon.

The logical suggestions in this report were not taken up or acted on, but it is hoped that the incoming administration will convey the substance of Comrade Dunlap's report to National Headquarters for its information, so that new regulations governing in the premises may obtain.

Comrade Conner, of committee to visit Ladies of W. R. C. here reported that the ladies of that organization had appointed a Flag Committee to make and present a flag to each Texas Regiment leaving for the war.

This announcement was received with applause.

Encampment adjourned to 9 a. m., 17th.

May 17.

Encampment met. pursuant to adjournment, when it was announced on the floor that Comrade S. E. Crowder of Parmley Post 4, late resident of Burleson, Tex., had that morning passed to his reward.

The announcement was quite a shock to all present, because the deceased had been for many years a member of the local post, and because he was long and favorably known to many visiting members now present. A committee, appointed to take immediate cognizance and formulate resolutions expressive of regret and condolence, presented the following:

Holt Hubbard, his good wife and his splendid choir, assisted by Professor Cahoon and Mrs. Helen Fouts Cahoon and those dear little tots, Miss Vivian and Master Minor, Mr. Rob Roy Price his Boy Scouts and Mrs. Alice McEwen, who so royally entertained us at St. Pauls M. E. Church last evening.

Accompanying this order will be found circulars from the National Association of the Vicksburg Veterans, calling attention to the National Memorial Reunion and Peace Jubilee of the Union and Confederate survivors, to be holden in Vicksburg National Military Park, October 16th, 17th, 28th and 19th, 1917. Comrades when purchasing tickets to the National Encampment at Boston, if wishing to take part in

this Peace Jubilee, should see that their tickets are routed home via Vicksburg, with the time limit considered.

VII. By reason of the lateness of this Encampment in May, the incoming Administration will not be afforded the may, the incoming Administration will not be afforded the line necessary for preparing and promulgating its Memorial Day order; the Department Commander therefore takes the liberty of calling the attention of all comrades to our sacred duty on that day and the Sabbath day preceding: As each succeeding year decreases our Roll-Call and increases our Roll of Honor, let each Post assemble at some house of worship on the Sabbath preceding Memorial Day, May 27th, and there listen to and participate in the sacred service; each offering his silent prayer for the peaceful rest of comrades gone before and for the preservation of our National Unity and Honor.

On Memorial Day, Wednesday 30th, place the Flag that he loved and followed during life on the mound where sleeps a comrade and scatter your choicest flowers over his resting place, not forgetting your prayer for his repose.

And the Angel Sandalphon will

"Gather your prayers as He stands,
They will change into flowers in his hands,
Into garlands of purple and red.

Then beneath the great Arch of the Portal Through the streets of the City Immortal Shall be wafted the fragrance they shed."

Let us not forget the reading of the order of Commander-in-Chief John A. Logan, instituting Memorial Day, followed by the reading of Lincoln's Gettysburg address.

These Headquarters are just in receipt of "Circular Letter No. 4" from Headquarters Department of South Dakota, dated at Hurley, S. D., Feb. 22nd, 1917, from which a few extracts are incorporated in this General Order on account of the Simon Pure ring of the words:

"THE FLAG OF OUR COUNTRY."

"Let every day be Flag Day!"

This is the hour that patriots are needed; and if you are a patriot, if you love your country, if you are willing that

your neighbors know just where you stand, show it by wearing or flying the Flag.

This should be the motto throughout the State, if we are to get in line with the rest of the United States, for more patriotism and more loyalty to the Stars and Stripes.

Every home, every place of business, should own a flag, and fling it to the breeze; wear a small American Flag on the lapel of your coat, ladies on their dress.

Let every person as a loyal citizen of this great nation instill into the minds and hearts of the future generations a profound reverence for the Flag; teach them that it stands a pre-eminent symbol for those principles of religious and political liberty embodied in the Constitution of the United States of America.

By this means we can show President Wilson and all the people of the world, that the Americans to a man are behind the President in his stand, and that all will rally around him to protect the Flag from any enemy who dares to insult it.

Let every member of the Grand Army of the Republic and Woman's Relief Corps do all in their power to promote this patriotic movement."

The following resolution was unanimously adopted by The Grand Army of the Republic, Department of Texas, at their 31st Annual Encampment, held in San Antonio, Texas, April 28-29, 1916:

Whereas: In the call of President Lincoln for volunteers to defend the Union, it was promised that all volunteers should receive the same treatment as the officers and soldiers of the regular Army; and,

Whereas: Placing full credence in said promises, the

young manhood of the nation rallied to its defense; and,

Whereas: After a lapse of more than fifty years, those promises in regard to the men who by capacity, merit and bravery earned promotion but have not received the treatment they promised and abundantly earned.

Therefore, be it Resolved: That the Department of Texas, Grand Army of the Republic, in annual encampment assembled, respectfully ask the Congress of the United States to recognize the just claim of the officers who led and cared for us during the dark days of the Civil War, by placing the remaining survivors on the Retired List with all the benefits accruing to officers of the Regular Army of like rank; and,

Be it further Resolved: That a copy of this resolution, duly authenticated, be forwarded by the Adjutant General at Cincinnati, Ohio, to all the members of Congress and Senators from the State of Texas, and to the Assistant Adjutant General of the various Departments of the Grand Army of the Republic, with the request that it may receive their favorable consideration and support.
